The following items of evidence were **re-submitted** and examined for the suitability of deoxyribonucleic (DNA) typing in accordance with a court order filed September 16, 2002 by University of Wisconsin Innocence Project:

Item C(1-5) - hairs recovered from paper hospital sheets

Item D10 - pubic hair combings (Penny Beerntsen)

Item D13 - fingernail scrapings (Penny Beerntsen)

Item F(1-2) - hairs recovered from a brown shirt.

## RESULTS

One apparent pubic hair (item C5) and one apparent head hair (item C3) reportedly recovered from the paper sheets were reexamined microscopically and found to be unsuitable for possible DNA typing. (These hairs were referred to in the court order as trial exhibit 38.)

One apparent head hair (item F2) reportedly recovered from a brown shirt was re-examined microscopically and found to be unsuitable for possible DNA typing. (This hair was referred to in the court order as trial exhibit 31.)

Thirteen (13) apparent pubic hairs were recovered from the pubic hair combings (item D10) reportedly collected from Penny Beerntsen. These hairs were re-examined microscopically and

eleven (11) of these hairs were determined to be suitable for possible DNA typing. (These hairs were referred to in the court order as trial exhibit 38.) Detectable amounts of DNA were present on two (2) of these eleven (11) hairs.

Fingernail scrapings (item D13) reportedly collected from Penny Beerntsen contained only one small fingernail clipping from the left hand. This small clipping was extracted for DNA typing. (This clipping was referred to in the court order as trial exhibit 38.)

The DNA detected from the two (2) hairs in the pubic combings (item D10) and the extraction from the fingernail clipping (item D13) was amplified using the polymerase chain reaction (PCR) method and typed for fifteen (15) short tandem repeat (STR) genetic markers as well as the gender marker Amelogenin (STR loci: D3S1358, THO1, D2IS11, D18S51, PENTA E, D5S818, D13S317, D7S820, D16S539, CSF1PO, PENTA D, vWA, D8S1179, TPOX and FGA) using the Promega PowerPlex® 16 amplification kit.

The DNA profile generated from one of the apparent pubic hairs in D10 (D10a) was consistent with having originated from a female individual. The DNA profile generated from the remaining hair in D10 (D10b) was consistent with having originated from a male individual. This profile occurs in approximately 1 person in 251 billion in the Caucasian population, 1 person in 162 billion in the African American population, 1 person in 1 trillion the Southeast Hispanic population and 1 person in 49 trillion in the Southwest Hispanic population. These statistics were based on a population database of unrelated individuals obtained from the Federal Bureau of Investigation (FBI). This profile was entered into the Combined DNA Index System (CODIS) and searched against local and state databases. This search resulted in a match with a convicted offender in the Convicted Offender Index of the Wisconsin DNA Databank.

The typing results from the fingernail clipping (item D13) indicated that the DNA originated from a female individual. No further information can be ascertained from these results.
