Mrs. Avery complained that she and her husband have been having marital problems for some time, it is to the point where she has left her husband and will be returning to Escanaba, Michigan. Mrs. Avery intends to file for divorce when she returns to Michigan. Mrs. Avery feared for her safety so contacted the Domestic Violence Center of Manitowoc. The Domestic Violence Center arranged for Mrs. Avery to stay at their emergency shelter until she can make arrangements to return to Michigan. A written statement was obtained from Mrs. Avery regarding the incident that occurred on February 8th between her and her husband. Mrs. Avery further stated that on February 8th Charles Avery shot her dog at their home. Two photographs were taken of injuries Mrs. Avery received, claiming bruises to her right upper shoulder and a reddened eye. Mrs. Avery does not want to pursue assault charges against her husband.

08/17/83 @ 1915 hrs.: Officer Stuhr arrived at the Avery residence and was advised by a member of the Mishicot Fire Dept. that a gas explosion had occurred in the area of the gas stove in the trailer belonging to Charles E. Avery, and that three subjects had been transported by private auto to Two Rivers Community Hospital. Officer Stuhr made contact with Donna M. Avery at the hospital. Donna stated that the three victims were in the process of removing the gas stove from its location in the kitchen of the trailer. After shutting off the gas valve and attempting to pull the stove away from the wall, the rigid pipe became stuck in the interior of the stove and a wrench of some type was being used to pry the pipe away from the stove housing. This apparently caused a spark which ignited gas, which had apparently built up from a leak in the system. The resulting explosion caused Charles E. Avery to receive burns to both of his arms. Donna Avery received facial burns, and Steven Avery received burns to his right arm.

After the explosion, the gas was shut off at the meter, resulting in no apparent damage to the trailer itself.

09/10/83 @ 1030 hrs.: After inspecting the Allan Avery residence located at the same location, I went with Mr. & Mrs. Charles Avery to their trailer home and observed where the rear door on the trailer, which would be located on the west side of the building, had been pried with a screwdriver or tire iron type instrument. Subject or subjects then gained access to the trailer home through this door. There is a possibility that some money has been taken from the residence, but the Avery's have not had time to inventory everyting to determine what, if any, ^{with} the total amount was that would have been taken. An Inventory/Consent sheet was left with Charles Avery to be completed and returned, along with his father's form, on Monday, 09/12/83.

All indications are that in both these break-ins someone quite familiar with the residences and general area would be responsible. However, neither family has any idea at this time as to possible suspects. As was the case in the Allan Avery residence, the Charles Avery residence is quite far removed from any roadway, and there are no other residences within close proximity that anyone could have seen or heard anything. *RJA* R.
