01/24/99 @ 1630 Hrs.: I, Deputy Jost, received information from Dispatch that I was to contact [REDACTED] at her place of employment. Upon making contact with [REDACTED] she told me her father, CHARLES AVERY, has been violating the rules of his condition of Probation which recently was placed on him by his Probation Officer, DICK SWADE.

[REDACTED] stated, this afternoon (01/24/99) at approximately 1500 hours and also yesterday (01/23/99) at approximately 1200 hours, her father came to the residence and went into the house without knocking. According to [REDACTED] one of the conditions of his Probation is that if he comes over to the house, he must first knock on the door. If nobody is home, he then can come in; or if someone answers the door, they must tell him he can come in before he is allowed to do so. [REDACTED] stated CHARLES has done this several other times; however, she is unsure of the dates of those incidents.

[REDACTED] also told me she learned CHARLES had a tap put on the phone. What she meant by this is apparently the garage phone is hooked up to the residence phone so whenever somebody calls out or somebody calls in to the residence, he can listen in on the conversation.

[REDACTED] assured me CHARLES did not knock on the door before entering. During the incident at approximately 1500 hours this afternoon, she was in the bathroom at the time getting ready for work when CHARLES walked in by her and stated that he did not think anybody was home and that he was leaving now. I asked [REDACTED] if there was a possibility she was using the hair dryer and she did not hear him knock. She told me she does not use a hair dryer.

[REDACTED] told me, due to the fact she believes CHARLES has a line running to the garage for the phone, she did not want to call from home. She does not believe it would be a good idea for me to call her mother at the residence for fear that CHARLES might intercept our conversation.

Please forward a copy of this report to DICK SWADE for his review regarding the rules and conduct of CHARLES' Probation. I told [REDACTED] to contact DICK SWADE on Monday, 01/25/99, to inform him of the activities that have been taking place.
