05/29/02 @ 1825 hrs.: I, Lt. Seim, met with ALMA LEACH at her residence in Two Rivers. ALMA indicated that she had left a station wagon parked at the EARL AVERY residence on Old CTH Y and that several items were now missing from the vehicle. ALMA indicated that she had been evicted from her apt. and had left the items inside the station wagon for storage reasons. She described the items as being several boxes of clothing, which she described as being new, and also a new VCR. She also stated that the tires on the station wagon had been changed and there were different tires on it than what were on the station wagon when she had it. She further indicated that the spare tire was missing along with several tools out of the back of the vehicle.

The station wagon was located on Polk St. I did examine it and did note that the tires on the vehicle were of several different designs; however, all the tires appeared to be in good condition. I also noted that there was nothing inside of the vehicle. ALMA indicated that somebody had pried open one of the doors to remove the items.

ALMA stated that she had left the vehicle on EARL AVERY's property for approx. 3 months. She also stated that EARL had the vehicle towed over to the AVERY junkyard on Avery Rd. and the vehicle had been left alongside of the road there for her to pick-up. ALMA stated that the vehicle has not been running for some time now and that she had intended to have it fixed, which is why she had also left it up by EARL AVERY.

I did leave an 023 form with ALMA to complete as soon as she figured out everything that was missing from the vehicle. She also indicated that she might be able to find the serial number for the VCR and that she would check into this because she had bought it at Wal-Mart.

After leaving ALMA's residence, I did make phone contact with CHARLES AVERY who runs AVERY junkyard. AVERY indicated that EARL had brought the vehicle on a flatbed approx. 2 weeks ago and had left it there on the roadway leading into the junkyard. CHARLES indicated that he does not recall seeing anything in the vehicle that he hadn't really noticed before. He stated that the vehicle had been parked on the edge of the road and that anybody could have broken into the vehicle if they wanted to.

I then made contact with EARL AVERY by phone. EARL indicated that yes, the LEACH vehicle had been towed out to his residence and that he had parked it in a wooded area in the back of the residence. EARL also indicated that he did recall seeing several boxes of what he described as "junk and trash" inside the vehicle, but nothing that appeared to be of any sort of value. EARL stated that the vehicle remained secured on the property and that when he towed it to CHUCK AVERY's business, he believes that the Market we see that the property and that when
