ASSIST CITIZEN / SUBJECT TOOK HER MAIL

07/12/11 @ 1115 Hrs.: I, Deputy E. Glaeser, spoke to TRISTA JIMENEZ in regard to this complaint about her not receiving her mail. TRISTA stated she lives with her boyfriend, CHRISTOPHER AVERY, on property owned by CHRISTOPHER'S father, CHARLES AVERY. The property is located at 12928 Avery Rd, Two Rivers.

TRISTA stated her complaint on today's date is that CHARLES routinely collects the U.S. mail for her and CHRISTOPHER. She indicated CHARLES purposely holds onto different mail items, not turning them over to TRISTA and CHRISTOPHER as a way to control them. TRISTA stated this is part of "the whole AVERY control thing." TRISTA stated she feels CHARLES does this intentionally to control her and CHRISTOPHER. I asked TRISTA if she ever saw CHARLES taking the mail from the mailbox. She stated she never witnessed him taking their mail but she indicated it is routine practice for CHARLES to collect the mail and take it to the salvage yard office and then distribute the mail to family members from there. I asked TRISTA if she considered getting a post office box or relocating off the AVERY property. She stated she and CHRISTOPHER are making plans to move off the AVERY property very soon.

I asked TRISTA what her wishes were on this date. She stated she would like an officer to make phone contact with CHARLES to inform him of this complaint and to request that he not interfere with any further U.S. mail that belongs to her or CHRISTOPHER.

I had TRISTA complete a 023 Form, on which she documented that she did not give CHARLES permission to intentionally intercept her mail and to hold onto that mail until he decided to deliver it to her and CHRISTOPHER (see attached).

07/12/11 @ 1135 Hrs.: I made phone contact with CHARLES reference this incident. CHARLES was advised of this complaint which was taken from TRISTA. He acknowledged that TRISTA and CHRISTOPHER live in a house on Avery Rd which is owned by him. CHARLES stated TRISTA, CHRISTOPHER, and their 3 children have lived in that residence for almost one year and they have not paid any rent to him. CHARLES stated he has a problem with TRISTA'S housekeeping abilities and standards. He indicated TRISTA'S residence is "always a foot and a half deep in dirty clothes any time you go to the residence." I asked CHARLES if he ever handled any of the U.S. mail that belonged to TRISTA or CHRISTOPHER. CHARLES stated it is common practice for him to bring in the mail to the salvage yard office and distribute the mail to family members from that location. I asked CHARLES if he ever intentionally held onto mail that belonged to TRISTA or CHRISTOPHER. He denied this type of action. CHARLES stated he has routinely sees CHRISTOPHER look through his mail, locate something that appears to be a bill, rip it in half, and throw it into the garbage.

I informed CHARLES that it appeared TRISTA is taking care of the bills for her and CHRISTOPHER and it was her request that no one interfere with the delivery of their mail. CHARLES stated, due to the problems he has been having with TRISTA and CHRISTOPHER, he may be making arrangements to have them move off his property. CHARLES stated he would not touch any of their mail in the future and he reassured me

that they could take care of their correspondence. He indicated he will not delivery any of their mail to them. I informed CHARLES that we appreciated his cooperation.
