AFFIDAVIT OF GARY HUNT

---

Now comes your affiant, Gary Hunt, and under oath hereby states as follows:

1. I am of legal majority and can truthfully and competently testify to the matters contained herein based upon my personal knowledge and to a reasonable degree of certainty in the field of computer science. The factual statements herein are true and correct to the best of my knowledge, information, and belief.
2. I am a Senior Forensic Examiner with QDiscovery, LLC. My curriculum vitae is attached as Exhibit A.
3. I have been ACE (AccessData Certified Examiner) certified since 2012 and CCE (Certified Computer Examiner) certified since June 2013. The authority overseeing the ACE is Access Data, a forensic tool developer and vendor, while the CCE authority is the International Society of Forensic Computer Examiners (ISFCE).



4. Over the course of my career in digital forensics I have conducted numerous digital forensic investigations.
5. In the past 4 years, I have testified as an expert before courts in a number of cases. A listing of these cases is included within Exhibit A.
6. QDiscovery was retained by Zellner & Associates July 31, 2017. I received a forensic image from Zellner & Associates later the same day, along with one report from the previous investigation conducted in 2006:

- *2006.04.21 - DCI (Fassbender) report re examination of Dassey computer.pdf*

7. It is my understanding from reviewing the report that the forensic image was generated from a computer seized in the Dassey household on April 21, 2006.
8. The forensic image I was provided was processed using the latest releases of several forensic tools including AccessData's Forensic Toolkit v6.2.1 (released May 2017) and Magnet Forensics' Internet Evidence Finder v6.9.3 (released August 2017). Magnet Forensics describes its tool as follows:

*"Magnet IEF is a digital forensics software solution that you can use to discover, analyze and report on digital evidence from various types of drives and devices. With Magnet IEF you can recover data from social networking and chat applications, cloud-based artifacts, web browser history, and much more."*<sup>1</sup>

9. At the time of the 2006 investigation, there were three leading forensic examination utilities; Encase, Forensic Toolkit (FTK), and X-Ways. It is important to note that the platforms have significantly evolved since the 2006 investigation. FTK specifically added new features and parsing capabilities allowing for more efficient investigations and greater insight into the data at stake. Additionally, Internet Evidence Finder (“IEF”) was not first released until March 22, 2009. The technology did not exist during the original investigation. The bulk of my analysis revolved around web activity which was streamlined by the use of IEF.
10. While the corpus of data contained within the forensic image I was provided has not changed, the tools available have dramatically improved since 2006 which allow examiners such as myself to more thoroughly search, review, and analyze the data contained with the forensic image.
11. During my investigation, I determined the following:
  - a. There was a single user account on the computer named “HP\_Owner”.
  - b. The HP\_Owner user conducted the following internet searches on various dates:

- c. On September 18, 2006, between 5:57 AM and 10:04 AM, the HP\_Owner user conducted 75 unique Google searches. These searches have been attached as Exhibit B.
- d. In addition to the recovered internet searches, cached internet search results were identified. These cached results grant the ability to see what the user saw, as well as the images that the user clicked on. A sampling of these images along with available metadata information has been attached as Exhibit C.
- e. Two pictures were found in the unallocated space<sup>2</sup>; the first showing Teresa Halbach and Steven Avery, the second showing only Teresa Halbach. These have been attached as Exhibit D for reference. Both images were carved<sup>3</sup> from the unallocated space of the computer hard drive. The first image was carved from sector 67,975,480 within the unallocated space. The second image was carved from sector 75,476,224 within the unallocated space. Since the files were recovered via data carving, there is no file system metadata available. The files' original path, file name, and created, accessed, or modified timestamps are not available, nor is there any information regarding how they

arrived on the computer.

12. In conclusion, the computer was used to run internet searches including (but not limited to) those identified in paragraph 11b and Exhibit B. Some images displayed as a result of the searches were clicked on by the user.

Additionally, two pictures of Teresa Halbach were recovered from the unallocated space. These images do not have any date attributes or information suggesting how they arrived on the computer.


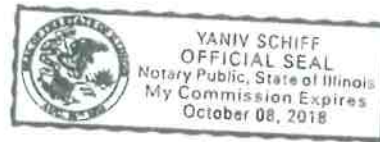

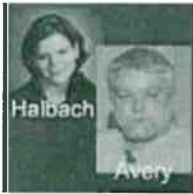
