On Sunday, November 6, 2005, at approximately 9:00 AM, Special Agent Tom Fassbender of the Wisconsin Division of Criminal Investigation requested technical assistance from the State Crime Laboratory in connection with the investigation of the disappearance of Teresa M. Halbach, D.O.B. 03/22/1980.

Forensic scientists John Ertl, Guang Zhang and Charles Cates departed from the Madison Laboratory at approximately 12:00 PM and proceeded to the scene at 12932 Avery Road, Town of Gibson, Manitowoc County. Upon arrival, at approximately 3:15 PM, they were met and briefed by Special Agent Fassbender and Investigator Mark Wiegert of the Calumet County Sheriff's Office. The Laboratory representatives assisted in a series of tasks at various locations on and in the vicinity of the property.

- 1) A site marked by a cadaver dog located in a gravel quarry, reportedly leased to Michels Materials, on the east side of Avery Road, was photographed, examined and sifted. As a result, apparent blood and apparent tissue were recovered. Subsequently, these were submitted to the Laboratory as items AM and AN.
- 2) Steven Avery's residence and garage were photographed, treated with luminol and examined for the presence of blood spatter patterns. Apparent bloodstains were identified for recovery by the Calumet County Sheriff's Office on the living

room entry door, the bedroom hall entry door area, and on the bathroom sink, vanity and floor. Cuttings of apparent bloodstains on the living room couch were recovered. Subsequently, the cuttings were submitted to the Laboratory as items CE, CF and CG.

- 3) Charles Avery's residence was treated with luminol and examined for the presence of blood spatter patterns. Cuttings of apparent bloodstains on the living room couch were recovered. Subsequently, these were submitted to the Laboratory as items CH and CI.
- 4) The contents of five burn barrels, reportedly recovered from the scene, were examined and sifted at the Calumet County Sheriff's Office. As a result, five items containing debris were recovered. Subsequently, these were submitted to the Laboratory as items AE, AF, AG, AH and AL.
- 5) Two wrecked vehicles, of interest to a cadaver dog, adjacent to the pond near where the Toyota Rav-4 was found, were photographed, processed and examined. Apparent bloodstains were located on the front seat cushions of a bronze/gold Honda Civic sedan. The fabric from the cushions was recovered. Apparent bloodstains were located on a white blanket and a piece of carpet on the middle seat of a gray/silver Renault Medallion wagon. The blanket and cuttings from the carpet were also recovered.
- 6) A potential burial site, of interest to both a cadaver dog and a bloodhound, located in the woods south of the end of Kuss Road, west of the scene, was photographed and examined. Nothing was recovered from this site.
- 7) A wrecked vehicle reportedly found to contain the Rav-4 license plates, and the immediate vicinity were photographed and examined. As a result, the license plates, a latent lift and a soda can were recovered. Subsequently, the license plates were submitted to the Laboratory as items AJ and AK.
- 8) A white camper trailer located near the vehicle with the license plates was examined. As a result, a pair of thong panties were recovered. Subsequently, these were submitted to the Laboratory as item CV.
- 9) Assisting Tom Sturdivant of the Wisconsin Division of Criminal Investigation, a burn pit located south of Steven Avery's garage was sifted. Debris, containing apparent bone and

teeth, was recovered. Subsequently, this has been submitted to the Laboratory as item AI.

All items of evidence recovered during the course of these activities were turned over to the Calumet County Sheriff's Office.

At approximately 9:30 PM on Tuesday, November 8, 2005, the field response team departed from the scene.

Photographs which were taken will be forwarded to your office under separate cover. The photographic negatives will be retained on file at the State Crime Laboratory in Madison.
