Subject: Interview with Steven Avery 07/20/06

Pursuant to a request from Mr. Avery, I traveled to the Calumet County Jail, this date, arriving at approximately 11:00am. Mr Strang had contacted the jail and advised them I was coming.

Jail Staff met me and requested identification, which I supplied via a Wisconsin Driver's License. The Jail Officer took the drivers license and returned a short time later and advised that the Jail Administrator wanted to know if I was a Licensed Private Detective. I advised that I was not but that I was meeting with Mr. Avery at the direction of, and as an employee of, Mr. Strang, Attorney for me Avery. The Jail Officer then advised that I would be required to interview Mr. Avery in the visitors room, via phone and then showed me to the visitors room. The phones are clearly marked that all "conversations are recorded.". At that time the Jail Officer asked how long the interview would take and I advised that it would be less than five minutes since I could not discuss anything over a recorded line and in those security conditions.

The Jail officer, a very large man, in uniform, left, but returned a short time later and took me to the interview room, which was the same room where I had previously interviewed Mr. Avery while in the company of Mr. Strang and Mr. Buting. As the Jail Officer was exiting he turned and stated "you know that everything here is recorded so anything said is at your own peril".

Mr. Avery was brought to the room and I advised him what the Jail Officer had said regarding recording. I advised Mr. Avery that it under the circumstances, he should not say anything to me about his case. He acknowledged that and said that he just wanted to tell me to check out "Scott", his sister's boyfriend. I stated I would relay that to Mr. Strang and Mr. Buting and then suggested that we confine our conversation to how he was doing in the jail, how the food was, etc. The remainder of the conversation merely involved those subjects.

During the conversation, I examined the room and could not locate any overt equipment, signs, or any indication or warning that the events in the room were being recorded. Since the Jail Officer appeared to be candid and honest in his advise that a recording was being made, I can only conclude that any such action is done covertly and, absent a direct notification such as that made to me, will occur without the knowledge or consent of the room's occupants.

Visitation of Steven Avery by his Attorneys

Effective immediately, anytime Mr. Strang or Mr. Bueting visit with their client, Steven Avery, they are to be checked for any type of recording devices or other contraband not authorized by me. On today's date Mr. Bueting brought a video camera into the visiting room in his briefcase which was detected on the security camera by jail staff. Their briefcases are to be inspected and searched for any device not authorized. Any detected contraband is to be confiscated.

If they should refuse to allow for the inspection of their briefcases, they will not be allowed to bring their briefcases into the jail. If they have a problem with this order, they are asked to take it up with the Judge who is aware of this situation.
