THE FOURTH AMENDMENT

The Fourth Amendment protects citizens against unreasonable searches and seizures without a warrant: "The right of the people to be secure... against unreasonable searches and seizures, shall not be violated, and no warrants shall issue; but upon probable cause..." While there are exceptions to the warrant requirement, as a

general rule, evidence obtained or an arrest made without probable cause is illegal. The evidence can be excluded from court and a citizen can recover damages for an illegal arrest.

THE FOURTEENTH AMENDMENT

The Bill of Rights as originally adopted granted rights to citizens in prosecutions by the Federal Government. The limitations against Bills of Attainder and Ex Post Facto Laws were the only protections directly addressed against state governments by the Constitution. In the aftermath of the Civil War the Fourteenth Amendment was passed and extended the Bill of Rights guarantees to the states. "No states shall ... deprive any person of life; liberty, or property, without due process of law; nor deny to any person within its jurisdiction the equal protection of the laws." The Fourteenth Amendment finished the work started by the Bill of Rights providing that all units of government must provide due process and equal protection to all persons in the United States of America.

INEFFECTIVE ASSISTANCE OF COUNSEL: FAILURE TO INVESTIGATE
