04-23-85 @ 1549 hrs. Officer Anderson made contact with Doris Weber at her residence in Mishicot. Mrs. Weber stated she has recently been harrassed by Steven Avery, who has driven by her residence an number of time in the last week, shouting obscenities at her and her family. Mrs. Weber stated on April 21st, Steven Avery drove by the residence and yelled to her daughter "Hey you fuckers". Also on Tuesday, April 23rd, Steven Avery drove by in the wrecker and on one occasion yelled out "Retards" and later in the day rode by again pulling his body partially out the passenger side of the vehicle and yelled "Hey you fucking retards". Mrs. Weber has a written statement to this effect. Officer Anderson did make contact with Steven Avery who stated he may have driven by the residence, however, if he yelled anything it was just "Hello" to Edward Weber. Steven Avery denied yelling any obscenities or anything else that would cause a disturbance.

Officer Anderson will attempt contact with another possibly witness on April 24, 1985, as that witness was presently working.

Judy Klein is a supposed witness to the conduct of Steven Avery in the Weber neighborhood. It is believed that Judy begins work sometime around 3:00PM. After reviewing this report with the shift commander it was felt that Mrs. Weber and Steven Avery's statements are in conflict and with no other independent witnesses it would be hard to collaborate either statement.
