09/04/04 @ 2344 Hrs.: I, Deputy Cummings, along with Mishicot PD Chief Gilbert responded to 12932 Avery Rd, Two Rivers, reference a 911 hang-up. According to Dispatch, they received a 911 call from a female subject stating she would call back. Upon call-back, the female subject reportedly just provided her address and the line was disconnected. When Dispatch attempted call-back, an answering machine picked up on 2 occasions.

As I was responding, Chief Gilbert advised that he was parked at the end of Avery Rd and STH 147, awaiting my arrival. A short time later, Chief Gilbert advised that a vehicle was leaving Avery Rd and was traveling SB on STH 147. Chief Gilbert followed the vehicle for a short distance on STH 147 before advising that it was swerving in its own lane of traffic and crossing the fog line.

After permission was given by the MTSO Shift Commander, Chief Gilbert conducted a traffic stop on Cherney Rd, just south of STH 147. It should be noted that shortly after Chief Gilbert conducted the stop, he stated the occupants inside the vehicle were the parties involved with the 911 hang-up. He also stated that the subjects advised him that they were in a disagreement this evening.

When I arrived at the traffic stop, I observed Chief Gilbert speaking with a female subject who was later identified as being JODI STACHOWSKI. When I asked STACHOWSKI about what was going on, she looked back at the vehicle and stated she could not tell us right now. At this point, I requested Chief Gilbert speak with STACHOWSKI as I was going to make contact with the operator.

I walked up to the vehicle and made contact with the operator, STEVEN AVERY. When I asked AVERY what was going on, he stated that he and STACHOWSKI entered into a verbal argument this evening while at their residence. AVERY stated he and STACHOWSKI were currently in a relationship and they lived together at the Avery Rd address.

I requested AVERY to exit his vehicle so that we could speak about this issue in more detail. AVERY complied with this request, and we eventually walked to an area in front of his vehicle. When I asked AVERY what they were arguing about, he informed me that the argument started over STACHOWSKI initially stating that she was going to be staying home this weekend. AVERY stated STACHOWSKI went to the races this evening and did not let him know. According to AVERY, he was "up north" when he called STACHOWSKI on her cell phone. When I asked AVERY if there were any physical acts taken by either party during the reported argument, he stated he pushed STACHOWSKI in order to have her sit down. When I asked AVERY if any other physical acts were taken, he stated there were not.

REPORT CONTINUED:

While I was speaking with AVERY, Chief Gilbert advised me over the radio that I should take AVERY into custody. I advised AVERY of this matter. He was placed into restraints without incident. AVERY was escorted to the back seat of my squad where he was secured inside.

After AVERY was secured, I walked up to Chief Gilbert's squad where I made contact with STACHOWSKI. According to STACHOWSKI, she arrived home at approx. 2310 hours, after attending the races. STACHOWSKI felt that AVERY had already been in the house because she did not see him enter. She also felt that AVERY was "hiding" somewhere. STACHOWSKI stated she and AVERY began arguing about her not staying home for the evening. STACHOWSKI stated AVERY left for "up north" and she initially advised him that she was going to be staying home for the weekend. After STACHOWSKI learned that AVERY left from up north early, she stated she called AVERY'S sister to see what time he left. According to STACHOWSKI, this upset AVERY even more.

At one point in the argument, STACHOWSKI stated she advised AVERY to "pack his shit up and get out." At this point, STACHOWSKI stated AVERY pushed her in the chest area, causing her to fall into a chair and hit her head. STACHOWSKI stated AVERY entered on top of her and began hitting her at which time she crawled up into a ball. During this reported hitting, STACHOWSKI stated AVERY advised her that he was going to "kill her." STACHOWSKI stated she eventually stood up and called 911. Before STACHOWSKI could tell Dispatch what was going on, she stated AVERY ripped the phone out of the wall. STACHOWSKI stated AVERY then began choking her, to the point where she lost consciousness. When she awoke, STACHOWSKI stated AVERY was dragging her to his vehicle. STACHOWSKI stated they left the residence and were eventually stopped by an officer.

It should be noted that there was no physical evidence to support STACHOWSKI'S claim that she was physically assaulted by AVERY. There were no marks around her neck which would have supported the choking claim. There also was no type of redness or markings where STACHOWSKI claims she was struck by AVERY. STACHOWSKI showed these areas to myself and Chief Gilbert; however, nothing was observed. STACHOWSKI also was not willing to complete any type of paperwork associated with the DV incident. It should be noted that STACHOWSKI did admit that she had been consuming alcohol this evening. A distinct odor of intoxicants was detected on her breath.

I, Deputy Cummings, transported AVERY to MTSO Jail where he was booked in for DC-DVO, violation of State Stat. 947.01 (see attached Arrest Data Sheet).

AVERY'S vehicle was pulled to the shoulder of the roadway by WSP Trooper Hyer to prevent any type of traffic hazards.
