09/19/04 @ 0131 Hrs.: I, Deputy Horneck, was advised by Dispatch that TRPD had information that BRYAN DASSEY was the suspect in a case they were working on and that he may harm himself. Dispatch later advised that the threat had been received at 2341 hours and it was now 0127 hours. Deputy J. J. Froelich and I responded to the scene.

09/19/04 @ 0146 Hrs.: Upon arrival, we were able to locate BRYAN DASSEY and his mother, BARBARA JANDA. DASSEY met us outside, and he did appear to be unharmed. DASSEY stated he did not have any thoughts of hurting himself, nor had he ever tonight. He advised that he did state to some people that he did not know what he was going to do at this point because of the allegations against him but he did not mean for that to be taken as a suicidal threat.

JANDA stated DASSEY has been fine ever since he has been home and that she will be with her son for the remainder of the evening. DASSEY stated he was suppose to respond to TRPD to speak with officers reference the incident at which time I advised him that it would probably be in his best interest to speak with them ASAP, while things are fresh in his mind. JANDA advised that she would drive DASSEY to TRPD to avoid any incidents.

Again, DASSEY stated he did not wish to harm himself and he had not made any threats of that nature at all. J.L.Horneck *JLH* /bjc
