06/15/05 @ 2059 Hrs.: I, Deputy Horneck, was advised by Dispatch that CHARLES and VIVIAN HERMAN'S son, DAVID HERMAN, called to report a problem with their neighbor, RICHARD ROHL, and a party who was at RICHARD'S house, STEVEN AVERY.

Upon arrival, we spoke with RICHARD and STEVEN. Deputy Raube and I arrived first. Sgt. Senglaub arrived on the scene later. I spoke with RICHARD while Deputy Raube spoke with STEVEN.

Upon speaking with RICHARD, he was obviously highly intoxicated. He advised that he has very bad back pain and is taking medication for his back. RICHARD stated he made no threats to his neighbors and he did not understand what I was talking about. I advised RICHARD that we received a call that the HERMANS were concerned that he threatened to harm them or kill them. He advised again that he knew nothing. RICHARD stated he spoke to the HERMANS several hours ago over the telephone but he did not have any problems with them and he gets along well with them.

In speaking with Deputy Raube, he advised that STEVEN stated he only arrived at the ROHL residence a few minutes ago and they were discussing his court case as he is assisting him with that case.

Deputy Raube and I went to the HERMAN residence. We spoke with VIVIAN briefly. I later spoke with CHARLES over the phone. CHARLES informed me that he received a phone call from RICHARD. He advised that he does get along with RICHARD for the most part; however, he has been acting stranger and stranger lately, especially when he is drinking. CHARLES stated RICHARD was talking to him about his .44 magnum which he sold. He did indicate that at one point, RICHARD made comments about being exmilitary and that he could "part" CHARLES' hair at 500 yards with an M16. He then made a comment to the fact that he could shoot him any time that he wanted to. CHARLES made the comment that he had "better shoot better than what he did the last time," this meaning the attempted suicide. CHARLES stated RICHARD did not find this humorous.

RICHARD mentioned STEVEN AVERY. CHARLES advised that RICHARD is becoming more and more paranoid and he feels that everyone is out to get him. He made comments about how law enforcement and the court system are corrupt and are out to get him. He advised that they "screwed over" STEVEN AVERY also. CHARLES advised that STEVEN did not have a clear history and he is not completely innocent with that matter. RICHARD did not appreciate this and stated he would tell STEVEN what was said. A short time later, RICHARD called back and spoke with CHARLES. He advised him that he told STEVEN what he said about him and that STEVEN said he was going to come over and "kick CHARLES" ass."

In speaking with CHARLES, he advised that he was not worried about RICHARD. He advised that he can take care of himself; however, he did not wish to have any further phone calls from RICHARD, unless RICHARD is sober. I advised CHARLES that I

would pass this information on to RICHARD and that they should recontact us if any other matters happen this evening.

Deputy Raube and I returned to the ROHL residence, along with Sgt. Senglaub, and we spoke with RICHARD. We advised RICHARD not to call when he is intoxicated and that CHARLES did not appreciate the comments made. RICHARD stated he was not threatening CHARLES. He was sorry that his comments were misunderstood. RICHARD stated he considered the HERMANS to be his friends as CHARLES had taken him to the hospital recently. I advised RICHARD that he should not make comments about shooting at them then.

No further action was taken. Units cleared from the area.

06/15/05 @ 2210 Hrs.: I, Deputy Horneck, along with Deputy Raube were again dispatched to respond to the HERMAN residence reference another phone call placed by RICHARD.

Upon arrival, we listened to a message on the answering machine. The message was not offensive or obscene in any way. It was RICHARD, indicating that he only called to ask him about his .44 which he sold. No other comments were made. In speaking with the HERMANS, I advised them that it would be in their best interest to not speak with RICHARD in any capacity in the future. They agreed and advised that they did not wish to have RICHARD on their property or have any phone calls from him. I advised them that I would advise RICHARD of this and if any further violations occur, we will look into Harassment charges or other appropriate charges.

Deputy Raube and I responded to the ROHL residence where we spoke with RICHARD again. He was advised very clearly that any further phone calls placed to the HERMAN residence could result in charges being placed against him. He indicated that he understood. I advised RICHARD that he should not trespass on their property. He stated he never goes to their house.

No further action was taken. No further complaints were received. JLHorneck
