NARRATIVE

ON 11/06/05, I, DEPUTY BARRY DEGNITZ, WAS AT PARKWAY ROAD AND HIGHLINE LANE, IN THE TOWN OF STEPHENSON, MARINETTE COUNTY, WISCONSIN. I WAS TO LOOK FOR A BLUE, 1996 PONTIAC GRAND AM 2-DOOR BEARING WISCONSIN ANNUAL REGISTRATION 187JFF, AND A 2005 INTERNATIONAL FLATBED TOW TRUCK BEARING WISCONSIN ANNUAL TRUCK REGISTRATION GD27469. I WAS INFORMED BY SERGEANT SIEVERT THAT AGENTS FROM THE WISCONSIN DEPARTMENT OF JUSTICE HAD WARRANTS FOR THE TWO VEHICLES. IF I SAW EITHER OF THESE VEHICLES BEING DRIVEN AROUND, I WAS TO STOP THEM AND SIEZE THEM PER THE WARRANT.

AT ABOUT 1150, I SAW A BLUE, 1996 PONTIAC GRAND AM, 2-DOOR, BEARING WISCONSIN ANNUAL REGISTRATION 187JFF. THE VEHICLE WAS BEING DRIVEN FROM HIGHLINE LANE. THE VEHICLE TURNED NORTH ON HIGHLINE LANE. I CONFIRMED WITH SERGEANT SIEVERT THAT I WAS TO STOP THIS VEHICLE. HE SAID YES. I STOPPED THE VEHICLE ABOUT 0.5 MILES SOUTH OF CTH X ON PARKWAY ROAD.

THE OPERATOR OF THE VEHICLE IDENTIFIED HIMSELF BY WISCONSIN PHOTO DRIVER'S LICENSE AS BRYAN J DASSEY M/W 07/15/85. THE PASSENGER IN THE VEHICLE IDENTIFIED HIMSELF BY WISCONSIN INSTRUCTIONAL PERMIT AS BRENDAN R DASSY M/W 10/19/89. BRYAN SAID THEY WERE COMING FROM HIGHLINE LANE. HE SAID THEY WERE GOING TO GET SOME SODA.

I RAN BOTH SUBJECTS THROUGH DISPATCH. SERGEANT SIEVERT CALLED FOR A TOW TRUCK. DETECTIVE BALDWIN AND DETECTIVE O'NEILL ARRIVED WITH TWO AGENTS FROM WISCONSIN DEPARTMENT OF JUSTICE. THEY SPOKE WITH THE TWO OCCUPANTS OF THE VEHICLE. WITT ARRIVED TO TOW THE VEHICLE. I FOLLOWED THE TOW TO THE MARINETTE COUNTY IMPOUND. I SECURED THE VEHICLE IN THE THE IMPOUND. I DISCONNECTED THE BATTERY CABLE. I SEALED THE DOORS, TRUNK AND HOOD OF THE VEHICLE WITH EVIDENCE TAPE.
