

Mr. Tadych stated that he is a cousin of Tom Janda, who was married to Barbra Janda (Avery). Mr. Tadych stated that Barbara is currently staying with him due to the trouble at her home. Tadych stated that that he has known Tom Janda most of his life, and has only known Barbara Janda for only 1 ½ years. Mr. Tadych stated that he is friends with both Barbara and Tom.

Mr. Tadych was asked about a Bobbie Dassay and stated that he knows him socially from interacting with him at family gatherings. He stated that he thinks that Bobbie is about 19 or 20 years old. Mr. Tadych stated that on Monday 10/31/2005 he didn't go to work that day because his mother was in the hospital in Green Bay. He stated that he drove to Green Bay and checked on his mother at the hospital. He stated that he left the hospital at about 2:15 p.m. and arrived at home around 3:15 p.m. Tadych stated that he got all of his hunting stuff together and loaded it into his vehicle a Green Ford Ranger with a cap. Mr. Tadych stated that he then backed out of his drive way to go west bound on High way 147.

Mr. Tadych stated that as he was driving west bound on 147 he saw a black Blazer S-10 going east bound on 147. He stated that "Bobbie" was going deer hunting behind his house. He was asked how he knew where "Bobbie" was going and he stated that "Bobbie" had asked him about hunting behind his house.

Mr. Tadych stated that as he was driving by "Bobbie" they waived at each other, and he continued on to his tree stand. He stated that this occurred at about 3:10 p.m. Mr. Tadych stated he saw "Bobbie" about ½ mile east of the Avery Junk Yard, just before the curve in the road.

Mr. Tadych stated that he arrived at his tree stand at about 3:30 p.m. and hunted until around 5:00 p.m. Tadych stated that once he had gotten out of the woods he returned to his truck and saw that he had two messages on his cell phone. Tadych stated that one message was from Barbara and the other was from his brother. Tadych stated that he only remembers receiving two messages on the 31st of October. The message from Barbara was about seeing his mother.

Mr. Tadych stated that he went to Barbara's house to pick her up to take her to see his mother in Green Bay. He stated that Barb is close to his mother so she wanted to go to the hospital to see her. Tadych stated that when he arrived at Barbara's house, she was standing out side with "Steve" (Steven Avery) and one of her younger sons. Tadych stated that he didn't know the boy's name, but he was one of the young kids.

Mr. Tadych stated that Barbara got in to his truck and they drove to Aurora Bay care Medical Center in Green Bay Wisconsin. Mr. Tadych stated that they stayed there for about 1-hour and they drove back and he got her home around 7:30 to 7:45 p.m. He stated that he got home around 8:00 p.m.

Mr. Tadych stated that at around 9:00 p.m. "Barb" drove out to his house to visit and she stayed there until 11 or 12:00 p.m. Mr. Tadych was asked if Barb was acting "ok" and he stated that she was fine and that nothing unusual was happening, they just talked. Mr. Tadych was asked when was the last time he saw Barbara Janda. Tadych stated that he saw her last Sunday 11/06/2005, and she told him that she was not allowed to get her dog from the trailer because of the police investigation.

Mr. Tadych stated that he has no idea what happened at the Avery place and he could not provide any further information and the interview was concluded.
