**AOLEA / SPEAK WITH STEVEN AVERY & DO CONSENT SEARCH OF RESIDENCE**

11/04/05: I, Det. Remiker, spoke with Lt. Lenk who advised that he received a call from the CASO, requesting that we make contact with STEVEN AVERY at his residence on Avery Rd. CASO requested that we make contact with STEVEN in an attempt to obtain additional information about his possible contact with TERESA HALBACH on 10/31/05. I was advised that on 11/03/05, Sgt. A. Colborn made contact with STEVEN and did attempt to obtain as much information as possible from him about his contacts and observations of TERESA when she was on the property on 10/31/05. Lt. Lenk and I drove to Avery Rd.

11/04/05 @ 1020 Hrs.: We arrived on the property. I went to the entrance door at 12932 Avery Rd, Two Rivers. This is a maroon in color trailer home with white trim around the windows and doorways. This residence is believed to be the residence currently occupied by STEVEN AVERY. I knocked on the entrance door for the residence several times but did not receive an answer. I did not notice any activity in the residence and/or any signs of anyone home at this time.

I walked over to the address identified as 12930A Avery Rd, Two Rivers, and attempted contact at this residence. This is a residence adjacent to the residence belonging to STEVEN. I again did not receive any contact from anyone at the residence.

Lt. Lenk and I went back to our vehicles and began exiting the driveway. As we were driving down the driveway, we noticed a golf cart type of vehicle traveling toward us. We made contact with the 2 individuals in the golf cart. The female subject who was operating the golf cart was identified as DOLORES AVERY. STEVEN AVERY was seated next to DOLORES, his mother. We identified ourselves as Dets. with the MTSO. I spoke with STEVEN about any additional information he may have about TERESA.

STEVEN stated he recalls that on Monday, 10/31/05, between 1400-1430 hours, TERESA came to Avery Rd and was taking photos of a maroon in color van parked near his residence. STEVEN stated he had very minimal conversation and contact with TERESA. He stated his contact with her was for approx. 5 minutes. I asked STEVEN to be more descriptive of what exactly took place between himself and TERESA. STEVEN stated, "It was just hi, how ya doin'," and then, TERESA left shortly there after. STEVEN stated TERESA has been on the AVERY property numerous times in the past and occasionally comes to the property to take photos of vehicles to be sold. STEVEN indicated to me that TERESA did come into his residence where he paid her for her services. She then immediately left.

I advised STEVEN that we are conducting an investigation due to the fact that TERESA is now missing and has not been seen or reported to be seen by anyone since 10/31/05. I advised STEVEN that we are attempting to obtain information reference the approx. time TERESA was at his property and another property on CORD B near STHY 310. STEVEN again reiterated that he believed the time was between 1400-1430 hours. STEVEN pointed to the maroon in color van which was parked near his residence. This van was bearing WI RP 343HXB.

I advised STEVEN that the CASO is requesting our contact with him. I asked STEVEN if he would be willing to provide me with verbal consent to search his residence for TERESA. STEVEN immediately provided verbal consent. He stated we could search the interior of his trailer home. I requested STEVEN to accompany Lt. Lenk and me to his residence to conduct the search. STEVEN and DOLORES drove to STEVEN'S residence.

11/04/05 @ 1030 Hrs.: We entered STEVEN'S trailer home. Also, previously, during my conversation with STEVEN, he seemed very surprised. I felt this was the first time that he had knowledge of or was informed that TERESA HALBACH is missing.

I did a quick interior search of the residence in an attempt to locate TERESA. I opened several doors within the residence, including a closet area inside STEVEN'S bedroom and additional closets/doorways within the residence. I did not locate any signs of TERESA inside the residence. Prior to leaving, we thanked STEVEN for his cooperation.

11/04/05 @ 1035 Hrs.: The consent search was completed.

11/04/05 @ 1038 Hrs.: Lt. Lenk and I were off the AVERY property.

CASO was contacted, and we did advise them of our contact with STEVEN and the consent search.
