AOLEA / RECEIVE INFO REFERENCE HALBACH MURDER

11/17/06 @ 1345 Hrs.: I, Sgt. Shallue, was transporting inmate ANDRES MARTINEZ from the MTSO Jail back to GBCI in Green Bay, WI, after he completed a court appearance earlier today. We were parked outside GBCI waiting for the gate to be opened when MARTINEZ started talking to me reference the TERESA HALBACH – STEVEN AVERY case. MARTINEZ began talking about how he knew AVERY from being in prison as a fellow inmate. He was familiar with AVERY and the operation of the AVERY SALVAGE YARD on STHY 147 in Manitowoc Co. On 2 occasions earlier that fall (September and early October 2005), MARTINEZ and his son went to the AVERY SALVAGE YARD to get different automobile parts for a vehicle they were working on. In the process, he spoke with AVERY on both of those occasions.

It should be noted that MARTINEZ was not under interrogation. He volunteered the following information to me without being questioned about the incidents at all.

MARTINEZ stated AVERY informed him that there was a young girl who has come to the salvage yard on several occasions to take photos of automobiles to be placed in the newspaper and/or a magazine reference vehicles for sale. AVERY told MARTINEZ that he was going to kill this female individual the next time she came to the property. At first, MARTINEZ did not believe what AVERY said; however, a couple of weeks later, news was out that TERESA HALBACH was missing and the last known person to see her alive was AVERY.

After MARTINEZ made these statements, the only thing that I asked him was if he ever contacted any authorities reference the information. MARTINEZ replied that he never made contact with anyone about the
