Greetings:

Bobby Dassey is and should be a suspect in the murder of Teresa Halbach. He is alleged to have consumed violent pornography found on his computer. Tens of millions of Americans have viewed the Netflix documentary *Making a Murderer* and are aware of some of the evidence that indicates Bobby Dassey may have been the killer rather than Steven Avery who was framed, at least once, by Manitowoc officials.

Therefore, I hereby formally request any and all records, evidence, documents, or any other materials in the possession of either of any of your offices, as well as of any of the offices of the State of Wisconsin or any of its subdivisions as well as any FBI offices, pertaining to the consumption by Bobby Dassey, or anyone else, of video games, including but not limited to any of the *Grand Theft Auto* video games. Also requested are any search warrant inventories indicating whether or not any video gaming materials were seized in the Dassey domicile(s).

Re: Public Records Law Request Per Wisconsin Statute 19.31 et sequitur and United States Freedom of Information Act (FOIA) Re State of Wisconsin v. Steven Avery

The reason these materials are being sought is that the *Grand Theft Auto* video games, for example, are *rape and murder simulators* upon which to interactively rehearse what was done to Teresa Halbach. Here are two video clips available on YouTube proving just that:

In addition, Grand Theft Auto video games allow one to simulate incinerating victims.

Violent video games have been linked to scores of killings around the country and around the world, including the Paducah school massacre of December 1, 1997. The undersigned represented the families of those killed by the teen who trained on a murder simulator video game. The undersigned he predicted with alarming specificity on NBC's *Today Show* as to the video game upon which the authors of the Columbine massacre trained two weeks before that video game-fueled massacre occurred. Paducah's killer, Michael Carneal, consumed violent pornography and violent video games, thereby inciting and training himself to kill three innocent <u>female</u> students. The extent to which these violent, pornographic images prepared him for his murders was proven in part by a "mirror image" of Carneal's computer hard drive successfully done by the Federal Bureau of Investigation after the Carneal family had a "delete party" to try to rid his computer of the incriminating violent, anti-female material.

It is alleged that similar deletions from the Dassey computer may have occurred for similar reasons. It is not known by the undersigned whether a mirror image recovery effort as to the Dassey computer was ever conducted by the FBI, but it should have been done it and can be done even now. This recreation of the Dassey computer, along with murder simulation/video game evidence, may help right this egregious wrong.
