On Sunday, November 6, 2005, at approximately 7:30 p.m., at the request of S/A Thomas J. Fassbender, S/A Kim J. Skorlinski, S/A Kevin Heimerl and S/A James Sielehr met with Barbara E. Janda, DOB and her niece, Carla J. Avery, DOB who is the daughter of Charles "Chuck" Avery, at the Avery Auto Salvage, 12928 Avery Road, Two Rivers. This is the location of on-going search warrant execution for Teresa Halbach who had been missing since October 31, 2005.

S/A Fassbender requested that S/A Skorlinski allow Barb and Carla onto the property, but not into any buildings. This was done in order for them to feed and water three dogs on the property, two behind Barb's house and one behind her brother, Steven Avery's house, and to allow Barb to take her cat out of her residence. (Previously, Barb had been interviewed by S/A James Holmes and she made the request during the interview.)

S/A Skorlinski, S/A Heimerl and S/A Sielehr escorted Barb and Carla from Barb's vehicle which remained park on Avery Road just past the squad car where the entry log was being maintained. They were escorted to the two residences and so they take care of the dogs and cat. The dog food was located just inside the door of Barb's garage. Barb was also allowed to open the door of her residence and call out her cat's name and the cat came to her. At Barb's request, S/A Skorlinski and S/A Heimerl then entered her residence to retrieve a cat leash and cat food.

While walking back to Barb's vehicle, S/A Skorlinski asked Barb how long her maroon van, which Steven was trying to sell for her through Auto Trader, had been sitting in front of her residence. She said it had been there at least a week and a half and had not moved during that time.

Barb was asked about the black and red Chevrolet Blazer at the corner of Avery Road and the access road to her residence. She said that is Steven's Blazer and it has been sitting there for several weeks. Barb said he is trying to sell the Blazer and the Pontiac Grand Prix located across the road from the Blazer.

Barb was allowed to check her mailbox, but she did not have any mail. Barb also made a request for a change of clothes for herself and her four boys, and S/A Skorlinski said he would forward that request to S/A Fassbender. Barb and Carla left the Avery Auto Salvage property at approximately 8:10 p.m.
