On 11-03-05 at about 0814 hours I, Off. Stone was dispatched to 1214 S 19th St. for a report of a 24-yoa female, and not The Rescue Squad had also been dispatched to this address. As I was responding, I noticed dispatch had updated the information on my computer screen, and upon reading it, the female was apparently cold to the touch.

When I arrived, rescue squad paramedics KERRY PECK, MARK VOELKER and KARL KOCH were already on scene. I went to the back of the house where the entrance to the upper apartment would be. The upper apartment would be where the 24-yoa female currently was. When I went into the apartment, the door at the upper landing was standing open, and I met BEVERLY ESCHER in the kitchen. ESCHER was very upset and said the 24-yoa female would be her granddaughter, CARMEN BOUTWELL. I saw JESSICA MILLER was seated on the couch and she was holding/cradling BOUTWELL. BOUTWELL had her head and shoulders on MILLER'S lap. The paramedics began working on BOUTWELL and placed BOUTWELL on the floor on her back. While I was in the kitchen, I noticed a glass-smoking device was on the kitchen table. The device would be commonly used for smoking marijuana. I had MILLER and ESCHER exit the apartment to allow the paramedics to work on BOUTWELL, and they went down to ESCHER'S lower apartment.

The paramedics attached a heart monitor to BOUTWELL, and were not able to detect a heartbeat or any breathing. I was advised by KARL KOCH that BOUTWELL was cold to the touch, had set in and was present in her knees. Sgt. Perronne had arrived to assist and I advised him to begin a log of everyone that entered/exited the apartment, along with the time. The paramedics advised nothing more could be done to assist BOUTWELL and left the scene. I notified Lt. Luctherhand of the death and of the age of BOUTWELL, and he assigned Detectives Vogel and Tech to respond to the scene.

I had noted that BOUTWELL was currently lying on her back, with her face turned toward the entertainment center. She was wearing a brown t-shirt, tan pants, white socks and she had her right black/reddish tennis shoe on and her left shoe was off and lying near her left foot. I could see her skin appeared a blue/gray color. The television was turned on as was the stereo, which the volume was turned quite loud.

I went downstairs and spoke with JESSICA MILLER. MILLER was upset and crying. I asked how she knew BOUTWELL, and she said she has been very good friends with BOUTWELL for many years. In further speaking with MILLER, she told me that MILLER, BOUTWELL, JENNIFER BROOKS and CATHY (CATHLEEN) BROOKS had all gone out last night. She said when she first got together with BOUTWELL that BOUTWELL had already been drinking. The four of them went to Studio 8, and then to another bar, but MILLER could not recall what bar they had been at.

At bar closing time, about 0200 hours, MILLER said she, BOUTWELL, JENNIFER BROOKS and CATHY BROOKS then walked to 1207 S 18 St. where MILLER and JENNIFER BROOKS live. MILLER went on to say that BOUTWELL and her then walked to BOUTWELL'S apartment at 1214 A S 19th St.; and JENNIFER BROOKS and CATHY BROOKS would have stayed at 1207 S 18th St. MILLER said when they left 1207 S 18th St., they took a case of beer from CATHY BROOKS' car and brought it to BOUTWELL'S.

They arrived at about 0230 hours, and it would have only been MILLER and BOUTWELL in the apartment. MILLER said she sat down in the yellow chair in the living room. She said she was drunk and had been drinking a lot when they were all out at the bars, and she was not feeling well. MILLER

IS BEING PROVIDED AT CONFIDENTIAL ITS CONTENTS ARE DESEMBLY CONFIDENTIAL AND NOT TO BE DISSEMINATED ALCY OF MARK said BOUTWELL brought her a can of beer, and she took two or three drinks from the can, and put it down and told BOUTWELL she did not feel that well.

MILLER recalled BOUTWELL saying she was going to switch the music, and MILLER said she must have passed out or fell asleep. She said she had only been at BOUTWELL'S apartment about 10 minutes before passing out or falling asleep. When asked what BOUTWELL had been drinking, MILLER said it would have been beer, shots of Dr. McGillicudy and other shots of liquor she could not recall. She advised BOUTWELL smokes marijuana, but she did not see her smoke any during the time they were together. I asked if BOUTWELL was complaining about not feeling well, and MILLER said BOUTWELL never said anything to her about that.

MILLER went on to say that she was awakened by ESCHER knocking on the door to the apartment. She said she woke up and was not sure where she was for a little while, then realized where she was. ESCHER had now quit knocking on the door, so MILLER exited the apartment into the stairwell and called out to ESCHER that she could come upstairs. When MILLER went back into the apartment, she found BOUTWELL on the living room floor in front of the entertainment center. MILLER said she shook BOUTWELL, but she did not respond and BOUTWELL felt cold. She said she realized BOUTWELL was not breathing and knew she was dead.

MILLER said she then lifted BOUTWELL into her lap while MILLER was sitting on the couch. She did not attempt any life saving measures. I asked MILLER what position BOUTWELL was in when she found her. MILLER showed me by getting into the fetal position, with her knees pulled up near her chest, then having her shins and face touching the floor (face down). I asked MILLER if she knew of any medications BOUTWELL was taking, and she was not aware of any. MILLER filled out a statement, which was turned over to Detective Vogel.

I next spoke with ESCHER. ESCHER said that around 0800 hours she went upstairs to wake up BOUTWELL for school. She has a key to the apartment and knocked on the door, but received no answer. She unlocked the door and when she opened it, found the chain lock on the inside of the door was secure and was not able to get inside. ESCHER then went back downstairs to her apartment. MILLER then came downstairs from the upper apartment and told her she could come upstairs. ESCHER saw BOUTWELL on the living room floor and MILLER was by her shaking her and trying to move her. She advised when MILLER rolled BOUTWELL over, there was a compact disc case under her face. ESCHER picked the case off the floor and placed it on the coffee table in the living. ESCHER realized BOUTWELL was not breathing, ran down to her apartment and called 911. I asked ESCHER if BOUTWELL had any illnesses, and she only was aware of an problem that she described as "slight". I asked if she knew of any medications BOUTWELL may have been taking, and she was not aware of any. ESCHER advised that BOUTWELL'S dog had been in the upper apartment and had been removed and brought down to her apartment before Emergency Personnel arrived. The dog was described by ESCHER as a black lab/springer spaniel mix.

I filled out the Investigation Check List (A) and the Death Scene Check List Examination of Indoor Death Scene (D) forms from the MTPD Death Investigation Packet, and they were attached to this report.

Detective Vogel had asked that I complete a Consent to Search form with ESCHER and to confirm she was the owner of the building 1214 S 19th St. I spoke with ESCHER and she again told me she is the owner of 1214 S 19th St. and rents the upper apartment to her granddaughter, BOUTWELL: I advised

11/03/05: At 0824 hours this morning, Lt Luchterhand requested Detective Tech and myself, Detective R. Vogel, respond to a death scene at 1214A S 19th St in the City of Manitowoc. The initial report was that there was a 24 YOA female deceased at that location. After obtaining necessary photo equipment and evidence articles, Detective J. Tech and myself motored to that location. Arrival at the location was at approximately 0835 hours.

Uniformed officers had maintained a death scene log of anyone entering and exiting the upper apartment. Officer Stone briefed both Detective J. Tech and myself on the information thus far which he had gained knowledge of. The entire residence was owned by BEVERLY J. ESCHER, who is the grandmother living in the downstairs apartment with the granddaughter, CARMEN BOUTWELL, residing alone in the upper apartment.

In the east living room of the upper apartment, was a body of a young female lying face up on the floor. Officer Stone stated that rescue squad paramedics had ran heart monitor tests with no heart function being noted. The heart monitor strips were lying on the adjacent coffee table.

I, Detective R. Vogel, had contacted JDC to make contact with the Coroner's Office. While waiting for the Coroner's Office personnel to arrive, I instructed Detective J. Tech to take complete photographs of the entire apartment including later collecting any evidence articles pertinent to the investigation that needed to be collected. Upon viewing the body, it appeared to be a younger 20's in age white female who was lying face up in an east/west direction on the living room floor with the facial portion towards the east direction. The body had been clad in a white T-shirt pulled up approximately mid-stomach region with a dark short-sleeve T-shirt over this. The subject had tan cargo pants with the zip-off knee portion intact with black boxers underneath. The subject had white and gray socks on with the right Puma red/black shoe on and the left Puma red/black shoe off of the foot lying adjacent to the body. The subject had two yellow/pink/black plastic bracelets on her left wrist with a ring on her left ring finger and four plastic bracelets on he right wrist. The subject had shorter dark hair with a pieced left eyebrow and at least two piercing to her left ear. There were noticeable flies in the area of the deceased crawling on the body. Lying on the kitchen table in an ashtray was four used filter cigarette butts and two unfiltered cigarette butts lying in an ashtray with the remains of a sucker wrapper. Also lying on the kitchen table was an open packaged of Top cigarette tobacco rolling papers and a Top cigarette tobacco pouch with tobacco located inside.

At 0908 hours Coroner #110RK reported to the scene and pronounced the female subject deceased. I earlier had instructed Officer Stone to remake contact with grandmother BEVERLY ESCHER in the lower apartment to have her sign a Consent to Search form.

I, Detective R. Vogel, was also informed by Officer Stone that the deceased was viewed and found this morning by both JESSICA A. MILLER, who spent the night at the BOUTWELL apartment in an intoxicated state who was awoken by ESCHER earlier this morning at approximately 0800 hours as ESCHER was knocking on the apartment door. It was at this point in time that MILLER, who was hung over and ESCHER located BOUTWELL lying facedown on the living room floor in an unresponsive not-breathing state. The body of BOUTWELL was turned over by MILLER and pulled ahead in the east direction towards a couch prior to officers' arrival.

At approximately 0955 hours this morning, I, Detective R. Vogel, made contact with BEVERLY ESCHER to gain the next of kin for CARMEN BOUTWELL. ESCHER explained that JOHN BOUTWELL is CARMEN's biological father and that CARMEN also has a by the name of who attends the at The biological mother was informed to be JUDITH WILSON who lives in the City of Two Rivers; however, she works at the present time at Lube Devices. Arrangements were made that Sgt Perronne would accompany Coroner #110RK to attempt to make contact with both JOHN BOUTWELL SR and JUDITH WILSON.

ESCHER stated that CARMEN BOUTWELL has lived in the upper apartment for approximately two years and the only known possible medical conditions is that she has a slight problem and that she's to cats.

JESSICA MILLER who was seated with ESCHER at the downstairs kitchen table stated that they had gone out to at least three bars last evening together, first at REPLAY, then STUDIO 8, and then GILLY'S Tavern. JESSICA MILLER stated that she knew CARMEN BOUTWELL was drinking in excess and had been also drinking numerous shots throughout the evening. Officer Stone previously had JESSICA MILLER write out a short statement and ESCHER asked if we could speak with MILLER further outside of the residence. MILLER was brought to the backyard area where Coroner #110RK and myself spoke with her further. MILLER stated that JENNIFER BROOKS and herself were waiting at their home for CARMEN to stop over so they could go out. Initially MILLER stated that they had been Frisbee golfing at Silver Creek Park together from approximately 3:00 PM to 6:30 PM and knew that CARMEN BOUTWELL had a 6-8 pack of beer to drink during that time period. and would drink from the time she MILLER stated that CARMEN BOUTWELL was a bad woke up in the morning until the time she went to bed. MILLER stated that she knew BOUTWELL for nine to ten years in length. Initially MILLER stated that CATHLEEN BROOKS, SHANNON PIESCHEL, JENNIFER BROOKS, RHONDA THEDE, and TARA BLUE had all gone out drinking to Nick's Bar (REPLAY), then to STUDIO 8, and then to GILLY'S TAVERN. In between going from REPLAY to STUDIO they also picked up a case of beer at the Kwik Trip at S 10th & Hamilton St. MILLER stated that CARMEN BOUTWELL was drinking big tap beers of what she thought was Bud Light and shots throughout the evening. At GILLY'S TAVERN, TARA BLUE, CARMEN BOUTWELL, and herself were playing Bar Dice for shots and she knew that BOUTWELL had at least three shots at GILLY'S. JESSICA MILLER also stated that at the REPLAY BAR a subject by the name of JUDY PETERMAN (KINTGEN) also was arguing with BOUTWELL and they had gone to the ladies restroom together for a short time, she doesn't know what may have happened in the restroom.

I had JESSICA MILLER re-write out a longer statement and her nearly one-page handwritten statement is also attached with this case file.

Once Sgt Perronne and Coroner #110RK made contact with the next of kin family members, notification was made by Coroner #110RK to contact Pfeffer Funeral Home and Crematory on S 14th St in the City of Manitowoc for removal of the body. Arrangements were also made by the Coroner's Office that a post autopsy would be completed on the deceased either late this afternoon or early

tomorrow morning, 11/04/05, by Forensic Pathologist Doug Kelly at the Waukesha County Medical Examiner's Office.

At approximately 1108 hours, Detective Tech and myself left the scene and went to 1207 S 18th St in the City of Manitowoc in attempt to speak with JENNIFER A. BROOKS and possibly other friends who may have been out with CARMEN BOUTWELL last evening. Upon arriving at that location, all the subjects that had gone out with CARMEN BOUTWELL were located which would include JENNIFER BROOKS, CATHLEEN BROOKS, SHANNON PIESCHEL, RHONDA THEDE (CERKAS), JESSICA MILLER, and also a subject living adjacent to BROOKS by the name of CHERYL HAUCKE. Pertinent information was obtained from all subjects at the apartment.

JENNIFER BROOKS had informed me that her cellphone showed that CARMEN BOUTWELL had called her at 0248 AM this morning, 11/03/05, in a drunken state asking her to call her. All subjects stated that CARMEN BOUTWELL had been drinking tap beer throughout the evening and also drinking shots throughout the evening and possibly in excess at GILLY'S TAVERN. CHERYL HAUCKE also stated that CARMEN BOUTWELL had stopped at her house at approximately 6:15 PM last evening when she already had a can of beer in her hand which she was drinking from. CATHLEEN BROOKS, JENNIFER BROOKS, SHANNON PIESCHEL, RHONDA THEDE, and CHERYL HAUCKE were asked to write out statements and their handwritten statements are now attached with this case file.

While speaking with the group, RHONDA THEDE, had received a phone call from TARA J. BLUE who had been working at Cedar Crest Ice Cream. TARA BLUE had informed RHONDA THEDE that CARMEN BOUTWELL admitted to her verbally last evening that she had been popping pills. Arrangements were made that RHONDA THEDE would pick up TARA BLUE and I would interview TARA BLUE at the PD within the next several minutes. All subjects were informed that should they have any further information, to regain contact with me as soon as possible.

Detective Tech and myself then left the S 18th St address and went back to the PD. Once there I met TARA BLUE and RHONDA THEDE in the front public parking area. RHONDA THEDE had gotten out of her green colored Chrysler LeBaron Coupe bearing WI RP 239CRW. Immediately RHONDA THEDE had turned over to me a pink/reddish colored pill which she stated she found on the floorboard underneath the area where CARMEN BOUTWELL was seated in her vehicle last evening going from bar to bar. RHONDA THEDE stated that she doesn't know where the pill came from nor are they hers nor has she seen any of the pills before. The pill was turned over to me by RHONDA THEDE.

I then interview TARA BLUE independently from THEDE. TARA BLUE stated that she has known CARMEN BOUTWELL for the last seven-year period. At approximately 7 PM last night, CARMEN BOUTWELL told TARA BLUE that she took some pills as TARA BLUE seen CARMEN BOUTWELL's eyes rolling towards the top of her head. BLUE stated that this had happened approximately three to four times last night and the longest time lasting at least ten seconds. The first time she observed this was right at CARMEN BOUTWELL's residence and that CARMEN BOUTWELL also stated to TARA BLUE that she had a thing. They then walked out the front door of her apartment and went to the

REPLAY BAR where she observed CARMEN BOUTWELL consume at least three mugs of beer. She also stated that she knew she had at least four mugs of beer at GILLY'S SALOON and at least four to five shots of Dr McGillicudy's liquor. TARA BLUE admitted that she was playing bar dice with CARMEN and JESSICA MILLER. TARA BLUE thought they left GILLY'S SALOON at 1:00 AM. TARA BLUE stated that CARMEN BOUTWELL was always messed up too much drinking and doing the pill-popping thing. TARA BLUE also stated that BOUTWELL was also the kind of girl who would do everything and anything and that CARMEN BOUTWELL admitted to her that she popped pills a lot. TARA BLUE also acknowledged that she never seen a reddish/pinkish colored pill like found in the THEDE vehicle before.

I had asked TARA BLUE to write out a written statement and her one-page handwritten statement is attached with this case file.

After speaking with TARA BLUE I again went to the 1214A S 19th St residence and the body was removed by Pfeffer Funeral Home officials at 1336 hours.

I, Detective R. Vogel, was contacted by JENNIFER BROOKS that I should return back to her residence.

I, Detective R. Vogel, did return to the BROOKS' apartment where I again met with the group of girls as stated previously in this report. BROOKS stated that she had found an open prescription bottle belonging to JAMIE HAYES in her kitchen cupboard. BROOKS explained that HAYES had lived with her for approximately two months and was arrested on a warrant at her residence some time ago. The prescription bottle turned over to me was ______ issued to JAMIE HAYES, MANITOWOC COUNTY JAIL, MANITOWOC which stated, "Take one capsule at" and then this area of the sticker was scratched. There were 17 pills left in the bottle which were oblong and reddish/pink in color which matched the one pill turned over to me earlier by RHONDA THEDE. The total prescription contained capsules, which said "No Refills". The pill bottle was turned over to me.

Upon BROOKS turning the pill bottle over to me, the subjects did acknowledge that BOUTWELL was known to pop pills for quite some time and it was known by her and her friends that a lot of the pills could have came from her stepfather living with BEVERLY ESCHER. The group explained that CARMEN BOUTWELL would steal the pills from ESCHER's husband.

I later made telephonic contact with Coroner #110RK and Coroner #110RK reported to the PD. Coroner #110RK was shown the prescription bottle obtained from JENNIFER BROOKS and also the pill found in the THEDE vehicle. Coroner #110RK contacted MANITOWOC PHARMACIES, the downtown location at 684-6789. It was found out that MANITOWOC PHARMACIES PHARMACIST, WENDY VLIETSTRA, had dispensed the product on 08/25/05. The pills were each and there was a total of pills prescribed. With the one pill turned over to me by THEDE and the pills left in the prescription bottle, made a total of pills missing.

Further investigation will follow in attempts to speak with JAMIE HAYES and JUDY PETERMAN (KINTGEN) will be made.

JAMIE HAYES stated when she was released on the previous occasion from MTSO Jail she had lived in several different places and did move her medication with her but at no point was JAMIE HAYES taking the medication on a regular basis or passing out/selling the pills. JAMIE HAYES spoke about the unknown location of the pills and when advised that CARMEN BOUTWELL was in possession of them, JAMIE HAYES stated she had no knowledge of how CARMEN BOUTWELL may have come into the possession of the pills. JAMIE HAYES was wondering if she was in trouble because CARMEN BOUTWELL may have overdosed on her pills. JAMIE HAYES was advised that it was a continual investigation. JAMIE HAYES was asked how many pills she had used after the prescription was filled. JAMIE HAYES replied by stating she used a couple while she was in the MTSO Jail and a couple after she was released but could not give me an exact count. In June of 2014 I spoke with JUDY who reported to the MTPD. JUDY stated she has heard some information about someone out there that may have some information by the name of JENNIFER. JUDY and I spoke about JENNIFER BROOKS who used to hang around with CARMEN.

AT this point JUDY spoke about CARMEN hanging around with CHERYL HAUCKE. JUDY stated she was told CHERYL was getting prescriptions and from "the out there for problems. JUDY heard that CHERYL was getting a months' worth of the prescription at a time and said she believed CHERYL would in turn, trade these medications for others of her choice. JUDY then said approximately six months later she was at an meeting and was approached by CHERYL who said she wanted to talk to JUDY. JUDY said CHERYL made the comment something to the effect of "I want to talk to you; some things are going on that I want to tell you about. JUDY said she was still very angry and upset about CARMEN passing away and did not talk to CHERYL. JUDY stated she had heard CARMEN had been going over to CHERY'S house a lot. When asked who she heard this from she said JENNIFER BROOKS. As a side note JUDY had said she heard someone had died of an overdose on CHERYL'S couch but did not know if this was true or not.

JUDY was asked to just free talk about what she remembered about the case and any other information she could provide. JUDY spoke about the morning CARMEN was found and she was with another girl in the apartment who we know to be JESSICA MILLER. JUDY then spoke a little about some of CARMEN'S friends such as JAYMIE HAYES and TODD KINTGEN.

JUDY then spoke about what she was told about the night in question. JUDY stated she was told about an argument that occurred between CARMEN and JUDY PETERMAN (KINTGEN). JUDY stated she was told about this from both JUDY PETERMAN and TODD KINTGEN. She was also told it had something to do with drugs but she does not know this to be 100% accurate. JUDY PETERMAN told JUDY WILSON she doesn't remember much about the night but also stated it wasn't her fault and she didn't mean it. JUDY WILSON was upset with the relationship CRAMEN had with PETERMAN because she believed PETERMAN used CARMAN for babysitting. WILSON also stated the two of them used to use drugs together such as pain killers and methadone but did not get into specifics about how she knew this.

I asked WILSON about CARMEN'S personal life during that time in her life and WILSON stated CARMEN was dating a girl from New Holstein by the name of SARAH MARKSMAN. WILSON stated she could not provide a lot of details about that.

WILSON also stated she heard CARMEN tried calling JENNIFER BROOKS several times on the evening before she passed. She also stated she heard some of the last bars the girls-were at for the evening were Glen's or Gilly's bar. WILSON could not provide any additional information at that time. I then went and spoke with JENNIFER BROOKS. I advised JENNIFER I was doing an investigation and wished to speak with her. JENNIFER stated she saw an article in the newspaper about CARMEN and was going to call to speak with someone about it so she was pleased I stopped by. JENNIFER had some personal family issues she was dealing with so an interview was scheduled for Wednesday, 06-25-2014 at 10:00 am.

information was gained. JENNIFER and I spoke about her providing a free narrative about what she remembers and that if I had any questions I would ask her as the interview progressed.

She said CARMEN would hang out with JUDY PETERMAN-KINTGEN quite often but when she did, she would not elaborate to JENNIFER about what they did. Maybe some of the smaller things but CARMEN would not tell JENNIFER about the drug use because she knew JENNIFER was against that, so if they would talk about it CARMEN would be evasive about it because she knew JENNIFER would "bitch". JENNIFER spoke about CARMEN and JUDY stealing some of DANIEL ESCHER'S pills. She said this was CARMEN'S grandfather. She also spoke about them stealing a script of his but did not know if this was the same incident and did not believe it was reported to the police.

JENNIFER then spoke about a time when she had people over at her house for a get together and people were drinking. She remembers CARMEN wasn't really drinking at all and states this was uncharacteristic for her because basically she was an . JENNIFER said she went to the bathroom and when she returned CARMEN was gone. JENNIFER thought this was strange so when she asked JUDY KINTGEN about it, JUDY said she did not know where CARMEN went but admitted the two of them had taken some methadone. JENNIFER was concerned so she called CARMEN who said she was at home and everything was OK.

JENNIFER then spoke about an incident approximately one week before CARMEN had passed. JENNIFER indicated that JAYMIE HAYES used to live with her and left some scripts behind when she moved out. CARMEN saw these pills and said to JENNIFER that she asked JAMIE for these pills and she said no, she could not have them. JENNIFER states that CARMEN asked her if she could take the pills now which JENNIFER said no to.

JENNIFER then spoke about the Wednesday night before CARMEN passed. She said a group of girls were going to go out to studio 8 that night for ladies night. JENNIFER said earlier in the day, CARMEN had a group of friends at her apartment in the afternoon for some drinks. JENNIFER said she and JESSICA MILLER, who lived with JENNIFER, went over to CARMEN'S house around 2:30 before they had to get a child off the bus. She said CAREMN and RHONDA were leaving to go play some Frisbee golf and asked if they wanted to go along. She and JESSICA decided to go for a little while. CARMEN needed to go to the laundry matt first but it was decided she would bring her comforter to JENNIFER BNROOKS house to be put in the dryer instead. So they drove to JENNIFER'S house first and then went to Silver Creek Park. JENNIFER states she and JESSICA left after a while and the plan was for the group of them to go out that evening. JENNIFER states CARMEN had people over that evening for some drinking before going out. JENNIFER states CARMEN came over to her apartment before going out and JENNIFER said she was getting ready. CARMEN said she was going to go next door to say hi to CHERYL HAUCKE and TONY EGGERT who had a residence which was the adjoining apartment. JENNIFER then said CARMEN came back to her place, grabbed her comforter and then went back to her residence on S. 19th St.

JENNIFER then said all of them went out and met at the Replay bar. She said prior to meeting, CARMEN and SHANNON PIESCHEL walked to the Kwik Trip and picked up a 30 pack of beer and put it in the trunk of her sisters, CATHLEEN BROOKS's car.

JENNIFER said when they got to the bar JUDY PETERMAN KINTGEN was all "messed up".

JENNIFER said CARMEN and JUDY were friends but weren't really getting along at that time. At one

point of the night, JUDY and CARMEN were arguing in the bar and then in the bathroom arguing. JENNIFER believed it had something to do with a stolen or missing purse that JUDY was blaming CARMEN for. JENNIFER said they actually checked on the two of them while they were in the bathroom and said when they came out, JUDY pushed CARMEN but that was all that happened. At this point, JENNIFER said they stayed for a while but JUDY was all messed up so they left her behind and they rest of them went to Studio 8. When asked who went to Studio 8 JENNIFER stated it was CATHLEEN BROOKS, SHANNON PIESCHEL, RHONDA THEDE (CERKAS), JESSICA MILLER, CARMEN BOUTWELL and herself.

JENNIFER said at this point, CARMEN was surprisingly sober. She was alert and didn't seem like she had taken anything. JENNIFER said on this night she was bored with the bar scene so she decided she was going to go home. JENNIFER said ROHONDA was supposed to be staying with CARMEN this evening and not driving back to Appleton but they could not find her. At this point CATHLEEN and JENNIFER dropped JESSICA and CARMEN off at Gilly's Bar, and she and CATHLEEN looked for RHONDA car. She said she did not hear any more noise so she believed JESSICA and CARMEN picked up the 30 pack of beer and went back to CARMEN'S because that was the way the vehicle drove towards. JENNIFER said she called CARMEN'S phone because she was upset but never spoke with her.

JENNIFER said the next morning JESSCIA called her hysterically telling her CARMEN had passed away. AT some point JENNIFER said several of the people were at her house consisting of SHANNON, CHERYL, CATHLEEN and RHONDA. She said RHONDA grabbed CARMEN'S comforter out of the car and this is when she found the pill that was turned over to Det. Vogel. When looking at it they believed this was the same one CARMEN was asking that was in the bottle that belonged to JAMIE HAYES.

At this point JENNIFER spoke about CHERYL gong to the program that same week in Appleton. She believed CHERYL went on that Tuesday before CARMEN passed. She described it as the "take home" and indicated CHERYL would get vials of methadone. JENNIFER said CHERYL told her she kept them in a locked box in the refrigerator and showed her in the past. JENNIFER described the methadone as vials with a cap of some sort that be punctured or pushed through. She said the medication is then consumed orally.

JENNIFER felt it was important to tell me about an incident that occurred. She stated at one point in time, ANTHONY EGGERT was staying with CHERYL and died in her apartment. She stated on this particular morning she, JESSICA and CHERYL were having coffee at her place and at some point she and JESSICA went shopping. When they returned she said CHERYL was running around on the front lawn telling them that ANTHONY was dead. She said when the police arrived and when the coroner was there, CHERYL was telling them not to do an autopsy. JENNIFER thought this was extremely strange and wondered why she would be saying that.

JENNIFER also believed at some point CHERYL was arrested for giving someone her meds and that person almost died. JENNIFER said CHERYL admitted to this and told her she had to call an ambulance. JENNIFER didn't know what CHERYL was charged with.

JENNIFER also wanted to tell me about another incident where she went to Green Bay with JUDY PETERMAN (KINTGEN), JESSICA and CARMEN. She states they went gambling and were planning on staying for the evening. On the way to Green Bay JUDY was already drunk and CARMEN was drinking. At one point JUDY and CHERYL walked off but JENNIFER didn't think much about it. They decide to leave and go to a bar in the Green Bay area. While there, JUDY was completely drunk. At some point, while in the bar, JUDY is falling all over the place and her eyes are rolling back into her head. The bartender asks what is wrong with her and they tell them JUDY needs to leave the bar and they will not serve her. I asked JENNIFER if she knew what was causing JUDY to be this way and she said yes. She went on to say they brought JUDY out to the car and put her in the back seat. They checked on her periodically and asked CHERYL what was wrong with JUDY. This is when CHERYL stated crying saying that she was sorry numerous times. CHERYL told them when everyone was at Oneida, JUDY asked her for some of her "take home" which everyone knew as the methadone. She said CHERYL brought it with her because they were planning on staying overnight. CHERYL told her that she poked a small hole in the vile so JUDY could take a little but JUDY pushed her finger through the barrier and drank the whole vile. They were concerned for JUDY so they called her nephew, TODD KINTGEN and he helped them and took JUDY for the night. JUDY thought this was important because it shows a pattern of CHERYL selling or giving her methadone away.

AT this point JENNIFER spoke about BEVERLY ESCHER, CARMEN'S grandmother and JUDY WISON talking about CHERYL calling JUDY. She states CHERYL called JUDY and told her she was going through some and one of the steps is to tell someone when you have done something wrong. She claims CHERYL called and said she felt so bad because she was the one that killed CARMEN because she gave her the methadone. She believed this was several years after CARMEN passed away. JENNIFER said she heard this from BEVERLY.

JENNIFER said she always believed CHERYL had something to do with it and actually tries to get her to admit to it on recordings but never did.

I did clarify one issue with JENNIFER and asked her how she knew JUDY and CARMEN were taking methadone and she said JUDY told her this. When asked if CARMEN ever told her she said no. No additional relevant information was gained from this point on in the interview and it ended shortly after.

Based on the interview I had with JENNIFER I wanted to conduct a follow up interview with JUDY. On 07-11-2014 JUDY reported to the Manitowoc Police Department. JUDY was told I wanted to clarify some information I had received about CHERYL and any information or contact she had with her. JUDY stated she never met CHERYL before but had heard about her from CARMEN. She stated at BRAD BROOKS funeral, CHERYL's name popped up about CARMEN'S death. JUDY said she did not hear a lot of information and it was just people talking about CHERYL. JUDY said she met CHERYL about 4-6 months later at an meeting. JUDY stated that CHERYL introduced herself. CHERY was complaining how she can't be in the medical field like she wants to be, how someone died at her house and other topics. JUDY said she started to "put two and two together" and believed she may know more about CARMEN'S death. JUDY said she was then in the parking lot with some other people and CHERYL came walking up to the group of people and asked and the complete and the co

SAMILEARE PORCE DEPARTMENT A COPA IS BEING PROVIDED AT YOUR REQUEST, BUT ITS CONTENTS ARE DEFAYED COMIDENTIAL AND NOT TO BE DISSEMINATED NICK REIMER JUDY if she was CARMEN'S mother. JUDY told her yes and CHERYL proceeded to say she felt responsible for CARMEN'S death and that she knew her and that she was sorry. JUDY stated she had to hold herself back after these comments were made and said she never got any other details about what CHERYL was talking about because she was too upset. JUDY said she had heard so many things about CARMEN'S death and really didn't know what CHERYL was trying to tell her. She said she started to ask around about CHERYL after that but never got any answers and never saw CHERYL after that.

I then asked JUDY about JESSICA, who found CARMEN in the morning hours. JUDY said she had always been apologetic about it because she "should have known" and that she was too drunk that night, passed out and just always felt bad about it.

When asked about JUDY KINTGEN, JUDY said that JUDY K. name came up and JUDY K. spoke with JUDY about overdosing a couple of nights before CARMEN'S death. She said that JUDY K said she can tell her where CARMEN got it, and that she was with CARMEN the night before she passed. JUDY K also admitted to having an argument with CARMEN on the previous evening but did not get into specifics but believed JUDY K was just trying to cover for herself. JUDY was told numerous times that JUDY K and CARMEN did a lot of drugs together.

When asked if there was anything else she wanted to add JUDY stated her stepfather had a prescription for in large quantities. She said about one month before CARMEN passed away, pulled his prescription because his pill count was off and he didn't have the levels in his system he should have. JUDY always believed this was a possibility because CARMEN lived about him. JUDY did not provide any additional information at this time.

On 11-18-2014 I made contact with CARMEN'S grandmother, BEVERLY ESCHER. BEVERLY agreed to meet with me and speak about the investigation. BEBERLY currently lives at 718 E. Linden Dr in Manitowoc, WI with a phone number of 920-684-7216. BEVERLY was advised I wished to speak about CARMEN and any information she may be able to provide.

BEVERLY stated she was living at 1109 S. 19th St in Manitowoc, WI at the time. She and her husband lived in the apartment below CARMEN. BEVERLY said CARMEN was going to school, had friends over sometimes, and some of her friends were OK and some were not, but she got along with everyone very well.

Prior to that, BEVERLY said she was a little concerned about CARMEN because CARMEN was not taking care of herself. She said CARMEN was having a hard time sleeping but made the comment "CARMEN was going to do what CARMEN was going to do".

At this time BEVERLY spoke about the day before CARMEN passed. She said CARMEN went Frisbee golfing with some of her friends and at one point CARMEN had come down to see her for a short amount of time and then left. BEVERLY said she heard CARMEN come home that evening and walk into her apartment. At that time BEVERLY said it sounded like two people were walking up the steps. The next day BEVERLY said she went upstairs to wake CARMEN up. BEVERLY spoke about working and taking CARMEN to school in the morning. BEVERLY said when she walked upstairs, the chain to CARMEN's apartment was locked and she knocked on the door several times but no one answered. BEVERLY said she was upset but then walked downstairs and JESSICA MILLER, who was upstairs in the apartment, said to BEVERLY "you can come up now". At this point BEVERLY said

She said she walked up to CARMEN and started shaking her but CARMEN was not waking up. BEVERLY said she pulled CARMEN back, looked at her and at this point she felt very cold. BEVERLY said JESSICA then made the comment that she's dead. BEVERLY said she told JESSICA to stay with her and this is when she went and called 911.

BEVERLY said she later called family and friends and told them what had happened. When people started to come over, BEVERLY said she heard later, that a group of girls went Frisbee golfing and then went out to the bars and everybody had a good time.

I spoke with BEVERLY about making the comment that CARMEN was having a hard time sleeping. When asked why, BEVERLY said it was because of school and relationship issues. She spoke about CARMEN being in a relationship with SARAH MARKSMAN at the time but indicated SARAH was incarcerated at MTSO Jail. I asked if she knew if CARMEN was taking anything to help her sleep and BEVERLY said not that she was aware of.

I then asked BEVERLY about medications she and her husband may have had in their apartment. When asked if there were any medications that CARMEN could have taken, BEVERLY said she did not believe so. When asked about her husband having medications, she did indicate he was on at the time. When asked if he had to go to the clinic, she indicated yes and said it was a prescription in pill form. I asked if she remembered how much her husband was prescribed at the time and she recalled him taking one pill three or four times a day, but could not recall the strength. When asked if she knew where her husband kept the medication, BEVERLY stated he usually kept it on him. She also said he was prescribed one month at a time and indicated he was seeing

I asked BEVERLY about keeping an entire month's worth of prescription on your body at all time. BEVERLY spoke about her husband being an over the road truck driver at the time and keeping the medication with him. I did ask the question if there was a possibility that CARMEN could have had access to the pills and BEVERLY said he was very careful with them, and she did not believe there was any possibility CARMEN could have gotten them. BEVERLY provided a cell phone number for her husband, DANIEL, of 920-901-9411.

I then asked BEVERLY if she has heard anything about CHERYL HAUCKE talking about this incident. BEVERLY provided me with some information but later stated this was information provided to JUDY, and then later to her. The following information was given to me.

Initially BEVERLY said CHERYL HAUCKE called her and made the comment she was calling to apologize for giving the drugs or methadone to CARMEN, and that she had died. BEVERLY said she told CHERYL, well at least she was being honest with her, and CHERYL said she had to because it was bothering her for a long time, and had said she can't even tell her how bad she feels. BEVERLY then said she went to JUDY and told her about this and she should tell the detectives. BEVERLY spoke about JUDY being in at that time and being in a bad place. She also said JUDY made the comment there is nothing that can bring CARMEN back. BEVERLY said she called the detective and told him about the phone call that was received. This was the point in the conversation when BEVERLY actually realized JUDY had received this information and she, BEVERLY, had contacted the detective. BEVERLY said the detective told her this information was hearsay and they would need

I asked BEVERLY if she recalled when this happened, and she believed it was approximately one year after CARMEN had passed.

When asked if there was anything else she could think of that may help out with the case, BEVERLY said she was told CARMEN was over at CHERYL's house and may have gotten something from CHERYL on the evening she passed.

No additional information was gained and the interview was digitally recorded and downloaded to the PD Server.

03/02/15: I, Detective Trilling, made contact with JESSICA HILL, AKA: JESSICA MILLER. It should be noted I had attempted since October of 2014 to speak with JESSICA but had been unsuccessful. JESSICA agreed to meet with me at her residence of 510 Jackson St, Mishicot, WI.

On this date of 03/02/15 at approximately 1730 hours I met with JESSICA HILL at 510 Jackson St, Mishicot, WI. JESSICA sat down with me and I spoke with her about the death investigation. The interview was digitally recorded and downloaded to the PD Server. For a more detailed version of the interview, please listen to the recording. The following information was gained.

JESSICA provided some general information such as her name, address, date of birth of 05/03/77, and a phone number of 920-652-2085. When asked if she knew why I was there to speak with her, JESSICA identified the interview as the investigation on CHERYL HAUCKE. I spoke with JESSICA about the investigation being opened back up, and asked her if she had read the newspaper article that was provided on this report. JESSICA said she did see the article and I explained to her some of the things I had done up to this point. I told JESSICA I would like to speak with her about what happened on that evening but also wanted to talk about the group of people she was hanging around with at the time.

At that point JESSICA indicated approximately a year ago she was living in Two Rivers, WI when she went over to a friend's house by the name of JOHNNY LAFLASH. JESSICA said there were family members over there and she was invited over. When she pulled up to the house, CHERYL HAUCKE was at the residence and immediately walked up to her and made the comment "it's been long times since I've seen you". JESSICA said one of the first things that came out of CHERYL HAUCKE's mouth was CHERYL asking JESSICA if she had any pills, or if she wanted to sell her any of her pills. JESSICA said sorry to CHERYL, and said she doesn't do that stuff and no she would not sell her any pills. According to JESSICA, CHERYL's response was sorry and then made the comment "sorry what I did to your friend. I shouldn't have given her that pill". At this point JESSICA told CHERYL to leave her alone.

I did clarify with JESSICA when this was and she indicated it was somewhere around the summer of 2014 or maybe March or April of 2014. She did remember it was on Hawthorne St in Two Rivers and again stated it was JOHNNY LAFLASH's residence.

JESSICA spoke about leaving that residence and later in the day her sister called her and asked if she, TINA, and CHERYL could come over to JESSICA's residence. She said she told her sister "don't ever

bring CHERYL around to my house because of what she said to me". JESSICA said she told her sister what CHERYL had said to her at the residence earlier in the day. JESSICA said she later contacted JENNIFER BROOKS and they talked a little bit about what CHERYL had said. JENNIFER asked if it was okay that she mention JESSICA's name to the PD when they speak with her. JESSICA said she was okay with that.

At this point I asked JESSICA what types of medication she is taking and she indicated she currently takes and When asked if there's any other forms of medication she takes, she said no, and spoke about being on these medications for approximately five years. When asked if she was using any drugs in 2005 when CARMEN had passed away, she said no, she was not using any drugs or any pills. I asked about her taking any methadone and she said she doesn't take it and she never did.

I asked JESSICA to repeat what she had told me earlier about being at LAFLASH's residence approximately a year ago. JESSICA again stated CHERYL HAUCKE had come up to her and made the comment, something to the effect of "I haven't seen you in a long time". CHERYL then asked JESSICA if she had any pills that she can get from her and JESSICA said no, and made the comment "why would you think I would do that." CHERYL's response was "I'm sorry" and then made the comment "well I'm sorry I gave that to CARMEN that night". I did ask JESSICA if CHERYL specifically said CARMEN's name and she responded yes. JESSICA said this is when she decided to call JENNIFER BROOKS several nights after this occurred. JESSICA then made the comment "we all knew she gave it to her".

I asked JESSICA if she knew what CHERYL had given her and she stated she knew CHERYL was going to the clinic and she would bring some home with her. When asked how she knew this, JESSICA said because she was living right next door to CHERYL at the time. JESSICA spoke about CHERYL's boyfriend also passing away and she believed it had something to do with CHERYL and her medications. At this point JESSICA said she believed it was methadone but she was not 100% sure.

I asked JESSICA if anybody else heard the comment that CHERYL had made and she said she did not know. JESSICA said everybody was talking and nobody made mention of it later. JESSICA said she told her sister, ABBY, about the comment later but she does not know how much her sister remembers because she was pretty intoxicated. She also said CHERYL was dating a person by the name of SCOTT, last name unknown.

I asked JESSICA to tell me what was going on and who she was all hanging around with at that time. JESSICA spoke about her, CARMEN, JENNIFER BROOKS, CHERYL HAUCKE, CHERYL KOTT, SCOTT, TANYA SCHMIDT, SARAH MARKSMAN, and JUDY KINTGEN. JESSICA said it was not a large group of people but the group of them would hang around. JESSICA did mention she was living at 1208 S 18th St at the time which was a side-by-side house and CHERYL was living on the other half.

I asked JESSICA to tell me what she knew about CARMEN's drinking and drug use at the time. She said CARMEN would drink every day, smoked a little bit of marijuana and popped some pills here and there. She also said she knew CARMEN went over to CHERYL HAUCKE's house to get some stuff. When asked how she knew that, JESSICA spoke about CARMEN coming over to her residence and then saying she was going over to CHERYL's house for a little bit. CARMEN would be gone for a

short amount of time and come back and it was very obvious she was on some type of drug. JESSICA also stated she believed CARMEN was also taking some of her grandfather's, DANIEL ESCHER, medication. JESSICA believed CARMEN was stealing it from him and she identified it as what she believed to be

I then asked JESSICA to tell me about the night CARMEN passed and what she remembers. JESSICA said they were at her house and a group of them were going to play Frisbee golf. CARMEN wanted to throw something into the dryer and then JESSICA spoke about grabbing a blanket. JESSICA said CHERYL was home at the time and prior to them leaving, CARMEN said she would be right back and then went over to CHERYL's house. JESSICA spoke about CARMEN getting something because as she was walking out to the car or towards them, she was putting something in her pocket. After that, JESSICA said they went to play Frisbee golf and then they went out. When asked who she was with, she identified herself, JENNIFER BROOKS, CARMEN BOUTWELL, and JUDY KINTGEN who they met at Replay Bar. JESSICA said there was one other person but she could not remember her name at that time. She said the last bar they were at was at the Replay Bar.

When asked how intoxicated she was, JESSICA said not until the end of the night and then she was relatively intoxicated. JESSICA also said she remembers CARMEN and JUDY getting into a fight. Initially she thought it was over meds but they later found out it was over a stolen purse or wallet. During the course of the evening, they figured things out and the fight was done and over with.

JESSICA said at bar close she was out with CARMEN and it was just the two of them. They went back to JENNIFER BROOKS' residence and initially the door was locked but JENNIFER let them in. JESSICA said they grabbed the case of beer they went over to CARMEN's house. JESSICA spoke about CARMEN being on the phone and CARMEN having a private conversation with somebody. JESSICA remembers CARMEN walking into a separate room and then later turning up the radio. JESSICA said she had one beer and then she fell asleep.

In the morning JESSICA said she woke up to CARMEN's grandmother knocking on the door. JESSICA said she probably walked right past CARMEN as she opened up the door for her grandmother to come in. JESSICA said her grandmother asked where CARMEN was and her response was she was sleeping. At this point they walked into the living room area and they both saw CARMEN lying on the ground by the radio. She said her grandmother tried waking her up and they could tell she was cold. JESSICA said she knew CARMEN had passed away and this is when they called the police.

I asked JESSICA if CARMEN had talked with her about what she was using and she said no. JESSICA then said she doesn't know anything other than what she told me and she had gotten methadone from CHERYL. When asked if she knew this to be the truth, JESSICA said yes.

No additional information was gained and JESSICA was asked to call me if she heard anything else.

11-12-2015 I made numerous attempts to speak with JUDY KINTGEN about the case but was unable to get ahold of her by phone or at her residence. I eventually made contact with CHERYL HAUCKE and she agreed to come to the PD for an interview. CHERYL was brought back to interview room #3 where the interview was conducted. For a more detailed version of the interview please watch the audio video recording. The following information was gained.

I received some general information from CHERYL and told she was not under arrest and I would not be reading her the Miranda form. I then advised CHERYL that we reopened the CARMEN BOUTWELL death investigation and this is what I wished to speak with her about. CHERLY immediately started talking about JENNIFER BROOKS spreading lies about her and telling people that, she, CHERYL is the one that killed CARMEN. When asked why she believed JENNIFER would say something like this, she said it was because she is on and JENNIFER is telling people CHERYL gave it to CARMEN. CHERYL said she never gave anything to CARMEN.

At this point I told CHERYL that I wished to take a step back and asked her about her relationship with CARMEN. CHERYL said she knew and met CARMEN through JENNIFER BROOKS and said she only hung out with her 3-4 times. She spoke about CARMEN being with JENNIFER at her house and also a time at a house party. CHERYL then said she remembered the night CARMEN passed and stated CARMEN care over to her house and did some laundry. CHERYL then said CARMEN left after the laundry was finished and the next morning, JENNIFER called her and said CARMEN had passed. CHERYL said she heard several months later that JENNIFER was spreading rumors that CHERYL was the one that gave her the drugs the night she passed.

At this point I spoke with CHERYL about what I knew historically about drug investigations in Manitowoc Co. I also told her I knew that CARMEN had a substance abuse and alcohol problem. I also spoke about what we knew about this case and additional information we had.

I then spoke with CHERYL about the case and asked her to tell me more about what she knows. CHERYL again said she met CARMEN through JENNIFER and JESSICA. CHERYL said she did party with these people at the time and this is when she met CARMEN. On the day before CARMEN passed, CHERYL said CARMEN came over to her house and in the afternoon hours to do some laundry. She said CARMEN lived about two blocks away and said JENNIFER lived next to her, CHERYL. I asked her why CARMEN would come over to her house to do laundry. CHERYL believed CARMEN may have liked her more intimately that she liked her back, or maybe it was because she just wanted to hang out more. CHERYL said CARMEN was excited about going out that evening and they talked while CARMEN did her laundry. She said CARMEN wanted her to come out that evening with them but CHERYL didn't want to. The next morning, JENNIFER called and told her CARMEN had passed. CHERYL did speak about CARMEN having some beer at her house too but left it outside because CHERYL was on probation.

I then asked CHERYL if she knew if CARMEN had used drugs at that time. CHERYL said she knew CARMEN used ecstasy and alcohol and spoke about wanting to, but never trying the ecstasy.

I then spoke with CHERYL about her being on the methadone at that time and asked her how she was prescribed it. CHERYL said she was going to the methadone clinic at the time and was taking it orally. CHERYL said she was given one dose a day and they had to take it in front of the nurse. She said they were given one take home dose on Saturdays to take on Sunday. (It should be noted this case was opened on a Thursday morning).

At this point I spoke with CHERYL about the interviews that were conducted on this case over the course of the last year. I spoke about speaking with JUDY WILSON, CARMEN'S mother. CHERYL made the comment she recently ran into her but it was a coincidence. CHERYL said they had a casual conversation and only spoke a little bit about CARMEN. I told CHERYL about what JUDY had said happened at the meeting. CHERYL was told that she made some comments about being sorry or that she contributed to CARMEN'S death. CHERYL said she does not remember anything like that and then said she couldn't have done that and wouldn't have done that. CHERYL was referring to not having methadone to give CARMEN. CHERYL also stated she didn't give away or sell her medications. I then spoke about the interview with JENNIFER. CHERYL was told that people said it was common knowledge that CARMEN would get drugs from CHERYL. At this point CHERYL spoke louder and said that was a lie, a blatant lie.

I then asked CHERYL if she remembered the trip to GB. CHERYL said she did and remembered JUDY KINTGEN getting very drunk and passing out. I spoke about the accusations that she gave JUDY some of her methadone and CHERYL said that never happened and it was a lie.

I them spoke about talking with CARMEN'S grandmother and how she heard CARMEN was getting drugs from CHERYL. CHERYL said the group of JENNIFER and her friends didn't like her and this was not the truth. I also spoke about the interview with JESSICA HILL. This interview produced the same information that CHERYL was providing drugs to CARMEN. I also spoke about the party in Two Rivers that JESSICA mentioned. CHERYL said she remembered it but never made any of the comments they are saying.

I reminded CHERYL about the investigation as a whole, the totality of the information we had received and how a lot of it points to her giving something to CARMEN. When we spoke about this CHERYL said she never gave anything to CARMEN. CHERYL continued to deny giving Carmen drugs or methadone and at this point I asked CHERYL if she would be willing to participate in a CVSA. CHERYL agreed but did ask me the question if she should get an attorney. CHERYL was advised I cannot give legal advice and she agreed to proceed.

CHERYL and I spoke about how the CVSA works and we spoke about the questions being asked. The relevant questions asked revolved around CHERYL providing CARMEN with any drugs in the days prior to her death, or if she provided CARMEN with any methadone. When the CVSA was completed I observed deception in the results. I spoke with CHERYL about the results and she continued to deny giving her anything. CHERYL then made the comment she did not wish to speak with me anymore and wanted to go home.

I provided CHERYL a ride home and spoke with her about the case. I asked her to give me a call if she wished to talk about it some more or provide me with any additional information. CHERYL did call the next day and said she believed JUDY KINTGEN would be the one we should look at since she believed JUDY had drugs at that time and may have been providing them to CARMEN. All recordings were downloaded to the PD server and CVSA forms will be attached to the report

I will make additional efforts to speak with JUDY KINTGEN about this case.

CHERYL did leave one message on my work phone but it sounded like she may have been intoxicated or using something else as her words were slurred and she just stated she didn't provide anything to CARMEN on the evening when she passed.

I did speak with JUDY WILSON about the case when she was at the PD on another matter. JUDY was advised that at this time we did not have any concrete information to pinpoint where CARMEN may have gotten the medication. JUDY was aware the investigation pointed towards several people including family that CARMEN may have stolen the medication from. JUDY was advised at this time we would be closing the case pending any new information that may come in.
