On Sunday, 11/06/2005, S/A James C. Holmes and S/A Joseph Kapitany interviewed BARBARA E. JANDA (DOB: 11/07/1964) at the Y-Go-By Restaurant, 104 East Church Street, Mishicot, Wisconsin, between approximately 3:39 and 7:00 p.m. The interview took place at a table located within the restaurant. JANDA brought another female with her to the interview. This female was CARLA J. AVERY (DOB: 01/13/1976) home address of E2704 County Highway G, Kewaunee, Wisconsin 54216, home telephone of 920-776-1193, and cell phone of 920-323-3225. S/A Holmes asked BARBARA JANDA if the agents could speak to her alone. JANDA agreed to speak to the agents alone. CARLA AVERY agreed to sit at another table within the Y-Go-By Restaurant during the interview of BARBARA JANDA.

During the interview of JANDA, S/A Holmes requested JANDA to write out a statement concerning her activities between 10/31/2005 and 11/05/2005. JANDA agreed to write out a statement. While JANDA was writing out a statement, S/A Holmes interviewed CARLA AVERY at the Y-Go-By Restaurant while S/A Kapitany sat with JANDA.

INTERVIEW OF CARLA AVERY

Between approximately 4:40 p.m. and 4:50 p.m. on 11/06/2005, S/A Holmes spoke to CARLA AVERY at the Y-Go-By Restaurant. S/A Holmes sat at a table within the restaurant with CARLA AVERY at that time. S/A Holmes asked AVERY if she would be willing to answer some questions he had for her. CARLA agreed to answer any questions asked of her.

S/A Holmes asked CARLA AVERY how she was related to the AVERY family. CARLA responded that CHARLES AVERY (identified as CHARLES E. AVERY, DOB: 07/13/1954) was her father. CHARLES AVERY resided at 12928 Avery Road on the Avery property, and he also worked at the Avery Salvage yard.

CARLA stated that she moved from her father's residence on Avery Road in approximately 1994. CARLA stated that she worked in Manitowoc, Wisconsin at Federal Mogul Factory making piston rings.

S/A Holmes asked CARLA if she had been at her father's residence or the Avery Salvage Yard since 10/30/2005. CARLA stated that she had not been at the Avery property at all during the past week. CARLA stated that the last time she had been on the Avery Road property occurred on 10/23/2005. CARLA stated that she had gone to the Avery property in order to attend a wedding for MIKE BOLINSKI (it should be noted that CARLA did not know how to spell MIKE'S last name). CARLA told S/A Holmes that the reason she

had stopped by the Avery property on that date was due to the fact that she had to drive CHARLES AVERY home after the wedding in order to drop his car off at his residence. CARLA thought that she would have dropped her dad off at his residence at approximately 1:30 a.m. on 10/23/2005. CARLA stated that she went home immediately after dropping her father's car off at his property.

CARLA stated that she had planned to stop at STEVEN AVERY'S residence on Friday, 11/04/2005 in order to use STEVEN'S computer that Friday evening. CARLA wanted to use STEVEN'S computer because he had Internet access and she needed to search for a fabric that she wanted to purchase so that she could make place settings for her wedding. CARLA stated that she was to marry STACY B. CHASE (DOB: 07/03/1970) and she was planning the wedding.

CARLA telephoned her dad on Friday evening, 11/04/2005, at around 4:10 p.m. CARLA contacted CHARLES AVERY on the Avery Salvage Yard's business phone (the yard phone) at that time. CARLA told CHARLES to tell STEVEN that she was not going to travel to STEVEN'S house to use the Internet.

CARLA had spoken to STEVEN on STEVEN'S cell phone approximately one half hour before her telephone contact with CHARLES AVERY on Friday, 11/04/2005. CARLA told STEVEN at that time that she wanted to use the Internet access on his computer. CARLA believed that STEVEN was by the Avery Salvage Yard at the time she had talked to him and she believed that STEVEN had mentioned he was helping CHARLES at that time.

CARLA stated that she did not go to STEVEN'S residence on 11/04/2005 as she had planned due to the fact that STACY and she had been preoccupied while they were in Manitowoc, and it had become too late for them to travel to STEVEN'S residence due to the fact that CARLA'S children were due to get off the school bus.

S/A Holmes asked CARLA when the last time she had spoken to STEVEN occurred prior to her telephone contact with him on Friday, 11/04/2005. CARLA believed she spoke to STEVEN AVERY on the telephone on Wednesday, 11/02/2005 at approximately 2:30 p.m. CARLA believed that her telephone call with STEVEN occurred at approximately 2:30 p.m. on that date because she had called him shortly before she went to work. CARLA told STEVEN on the telephone at that time that she wanted to use STEVEN'S computer in order to obtain Internet access. STEVEN told CARLA during that telephone conversation that he had plans to go up north over the weekend so she could come to his house by on Friday, 11/04/2005 in order to use his computer. CARLA told S/A Holmes that when STEVEN told her he was going to travel up north over the weekend, CARLA knew STEVEN was talking about going to the AVERY family's cabin located outside of Crivitz, Wisconsin.

S/A Holmes thanked CARLA for her cooperation. The interview ended.
