On Thursday, 11/10/2005, S/A James C. Holmes obtained one (1) sealed brown bag containing a garage door opener wrapped in duct tape from Wisconsin Crime Laboratory Evidence Technician Fran Lutz. Wisconsin Crime Laboratory personnel had obtained the aforementioned garage door opener from the Toyota Rav 4 that belonged to TERESA M. HALBACH (DOB: 03/22/1980) during evidence processing of the vehicle. S/A Holmes documented the aforementioned garage door opener on DCI property receipt #D6263. A copy of DCI property receipt #D6263 and the Wisconsin Crime Laboratory's Evidence Release form will be included in the case file.

**TESTING GARAGE DOOR OPENER AT AVERY FAMILY PROPERTY**

On Thursday, 11/10/2005, between approximately 3:45 p.m. and 4:00 p.m., S/A Thomas J. Fassbender and S/A Holmes tested the aforementioned garage door opener at all garage/shed doors located on the AVERY SALVAGE YARD'S property, 12930 Avery Road, Two Rivers, Wisconsin, to include all property belonging to AVERY family members that were located on or near the AVERY SALVAGE YARD'S property. The garage door opener did not open any garage or shed doors on the AVERY family members' properties.

**TESTING GARAGE DOOR OPENER AT TERESA HALBACH'S RESIDENCE**

On Thursday, 11/10/2005, at approximately 7:35 p.m., S/A Holmes tested the aforementioned garage door opener at the residence where TERESA HALBACH resided, W3637 County Highway B, Hilbert, Wisconsin. The garage door opener opened the garage door on the garage attached to HALBACH'S residence.
