On Friday, November 11, 2005, between the approximate hours of 10:02 am and 10:28 am, Special Agent Matthew D. Joy and Special Agent in Charge Peter M. Thelen interviewed James Alan Marshall at the Josh R. Radandt property, namely the gravel pit area located adjacent to the Avery Auto Salvage Yard, located in the Town of Gibson, Manitowoc County, Wisconsin.

SAIC Thelen had previously received information that Marshall frequently hunted on the Radandt property in the vicinity of the Avery Auto Salvage Yard.

During the course of the interview, Marshall provided the following information:

Marshall had last been at the Radandt property on Saturday, November 5, 2005, with his father to engage in turkey hunting. At that time, Marshall drove through the Radandt property from the hunting cabin, south through the gravel pits.

On approximately Tuesday, October 18, 2005, Marshall had walked through the Radandt property while turkey hunting. Marshall stated that that had been his most recent time walking (as opposed to driving) through the property area adjacent to the Avery Auto Salvage Yard. Also present with Marshall on that occasion was Jody L. Popp.

Marshall stated that on Friday, September 23, 2005, he, along with Popp and Gregory A. Phillips, had been goose hunting from the hunting cabin area. Two geese had been shot, and ultimately one flew near the vicinity of the Avery Auto Salvage Yard, and more specifically, near the residences located at the Northwest corner of the property area. Popp and Phillips went to the property to retrieve the fallen goose, and at that time had contact with one of the Avery family members. Marshall was unsure with whom Popp and Phillips had contact.

Marshall stated that since October 1, 2005, Marshall had been hunting or visiting at the Radandt property on approximately 15 occasions.

When asked if Marshall observed any changes at/near the Southwest entrance to the Avery Auto Salvage Yard, Marshall stated that he did not, only that Marshall did not remember seeing an old Ford Pinto which was now located on the north side of the gravel conveyors on previous visits to the area.

Marshall stated that Wayne Marcelle, b/t/b Wayne R. Marcelle, whose telephone number Marshall identified as 920-755-4447, traps on the Radandt property as well and may be able to provide additional information about the area.

At approximately 10:28 am, the interview was concluded.

On Wednesday, November 16, 2005, S/A Joy took digital photographs of the vehicles at/near the north side of the gravel conveyors in the area where Marshall was referring to, whech were subsequently transferred to a compact disc.
