On Wednesday, November 9, 2005, at approximately 1:20 p.m., S/A Debra K. Strauss and S/A Luis A. Ojeda made contact with Barbara Janda (a/k/a Barbara Dassey). Janda was advised that a search warrant had been issued for Janda's DNA along with her finger and palm prints. S/A Strauss advised Janda that, even though she was not under arrest, she was considered to be in police custody and Janda was unable to leave. At that time, S/A Strauss read Janda her Miranda Warnings. Janda indicated she understood her rights as they had been read to her by S/A Strauss. Janda then signed the Miranda Warning waiver form, indicating she had been advised of her rights.

S/A Strauss read Janda her Miranda Warnings on the front proch of Earl Avery's residece. S/A Strauss asked Janda if the Special Agents could go inside. Janda said she had to go inside and check with Earl Avery. Janda returned and said Earl did not want anyone in the house. A short period of time later, S/A James Siehler and Calumet County Investigator Gary Steyer arrived at the Avery residence with a search warrant for DNA and finger and palm prints for Earl Avery. When Janda was asked where Earl Avery was, Janda responded Earl was not home and she did not know where he was

It was later determined tat Earl Avery was at home and he was hiding in one of the rooms upstairs.

S/A Strauss provided the signed Miranda Warning waiver form to S/A Joseph M. Kapitany and Calumet County Investigator Wendy Baldwin. S/A Strauss left Janda in the custody of S/A Kapitany and Inv. Baldwin.
