On Saturday, November 5, 2005, S/A Alan S. Hunsader began assisting with an investigation concerning the disappearance of Teresa Marie Halbach, F/W, DOB 03/22/1980. While assisting with this investigation, S/A Hunsader was advised by Calumet County Sheriff's Department Detective Mark Wiegert that an item of interest had been found in the residence of Steven Avery, M/W, DOB 07/09/1962. Detective Wiegert further identified that this item was a for sale sign with the address 3302 Zander Rd., written on the back. Detective Wiegert further advised that also written on the back of this for sale sign was the cellular telephone number for Halbach. This number is as follows: 920-737-4731

Detective Wiegert then asked S/A Hunsader to make contact with this Zander Rd. address in an attempt to determine if parties at that location knew Halbach or the Avery's, and to find out why this sign was located in Avery's trailer. S/A Hunsader agreed to this and made several attempts to contact parties residing this at the Zander Rd. location.

It should be noted that this residence is for sale and is clearly marked with a for sale sign adjacent to the road on the property. It should also be noted that no contact was made with any individuals at this residence during these attempts and that upon looking into the residence; the residence appeared to be unoccupied. S/A Hunsader made contact with a real estate agent involved with the sale of this home, identified by the name of Tommy, last name unknown, 920-662-1000. Tommy advised S/A Hunsader that the residence located at 3302 Zander Rd., in Manitowoc County, the residence in question, is for sale, with a list price of \$194.900 and that the list date for this property was August 19, 2005. Tommy advised that the property was vacant at that time, and that the selling party is named Jim Bowling (phonetic), residing in Pennsylvania, with a work number of 1-715-770-2439 extension 10. S/A Hunsader attempted telephone contact with this party at this telephone number, however, contact was not made. S/A Hunsader left a voice message for Bowling to return S/A Hunsader's telephone call. S/A Hunsader also left a callback number for Bowling. S/A Hunsader identified himself to Bowling as an investigator for the State of Wisconsin and briefly explained the situation to Bowling on this message.

On Thursday, November 10, 2005, at approximately 10:00 a.m., S/A Hunsader received an incoming telephone call from a male party who identified himself as James Bowling. Bowling advised that he had recently received S/A Hunsader's voicemail message and was returning that telephone call. S/A Hunsader again explained to Bowling the nature of the situation concerningthe for sale sign and the aforementioned information written on the back of it being found at the Avery trailer. Bowling stated that he is familiar with the on-going investigation occurring in Wisconsin concerning Halbach. Bowling initially stated that that information did not ring any bells. Bowling stated that he did not know how that sign got to that location. Bowling stated that he had not bought a car or sold a car recently. Bowling further stated that the missing party, Teresa Halbach, is not friends with his daughter. Bowling then stated that he did have a daughter named Erica Bowling that resides in Green Bay and that she did have friends that knew Halbach. Bowling stated that he would provide Erica's number to S/A Hunsader but did not have that number available at that time. Bowling then stated that he would go and obtain that number and call S/A Hunsader back. This telephone call terminated at that time.

A short time later, Bowling again called S/A Hunsader back and advised that Erica Bowling's telephone number in Green Bay is 920-471-6376. Bowling advised that Erica Bowling resides with a party named Jeff, last name unknown and that Jeff knows Halbach. This concluded information received from Jim Bowling at that time.

At approximately 11:05 a.m., November 10, 2005, S/A Hunsader attempted telephone contact with Erica Bowling at 920-471-6376 and received a voicemail message. S/A Hunsader left Erica a message identifying himself as an investigator for the State of Wisconsin and requested a callback from Erica. S/A Hunsader provided Erica with his telephone number.

S/A Hunsader received a callback message from Erica during the evening of Thursday, November 10, 2005.

S/A Hunsader again attempted contact with Erica on Saturday, November 12, 2005, at approximately 10:40 a.m. S/A Hunsader received no answer and again left a request for callback.
