On Saturday, November 12, 2005, at approximately 11:35 a.m., S/A Alan S. Hunsader made telephone contact with Erica L. Bowling, F/W, DOB 09/09/1979, at telephone number 920-471-6376. Bowling resides at 2209 Lake Side Place, Apt. 3, Green Bay, WI 54302. S/A Hunsader was speaking with Bowling at this time, to attempt to determine why a for sale sign was located in Steven Avery's residence in connection with an investigation into the disappearance of Teresa Marie Halbach, F/W, DOB 03/22/1980.

Upon speaking with Bowling, S/A Hunsader identified himself to her as an investigator with the Wisconsin Department of Justice assisting with an investigation into the disappearance of Halbach. S/A Hunsader then explained to Bowling that the nature of this telephone call concerned the for sale sign, located in Avery's residence. S/A Hunsader further advised Bowling that on the backside of that for sale sign was written the address 3302 Zander Rd., along with the telephone number for Teresa Halbach. This number is as follows: 920-737-4731.

Bowling stated that during the summer of 2001, she was residing with her father, James Bowling, at this Zander Rd. address and at that time, sold a vehicle further described as a Pontiac, 2-dr., Grand Am, maroon in color, from that location. Bowling advised that there was a for sale sign on this vehicle at that time. Bowling advised that the parties that bought this vehicle were a mother and father, who bought this vehicle to give to their 16 year old daughter as a gift. Bowling could not remember the names of these parties. According to Bowling, that was the only thing she could think of for a reason as to why this for sale sign with the aforementioned information would be located on the Avery property. Bowling further stated that she thought that at some point the people that purchased this car from her at that time, got rid of the car and somehow that vehicle, along with the for sale sign ended up at the Avery junkyard.

Erica Bowling further stated that she never met Halbach and never sold a vehicle to Halbach. Erica Bowling denied knowing the Avery's and also stated that she believed her father did not know the Avery's. Erica stated that neither she nor her father had any known dealings with the Avery's.

Erica Bowling stated that she resides with a party named Jeff Smith and that Jeff Smith is friends with an individual named Randy Roethle, 920-360-7543. Erica explained that Randy and Randy's girlfriend, Carrie Hoops (phonetic), were very good friends with Halbach and that Jeff Smith knew Halbach through Randy and Carrie. Erica stated that she is friends with Jeff, Randy and Carrie.

Erica further advised that her parents have been divorced since 1997 and that her mother resides in the Manitowoc area, but does not know the Avery's either. This concluded the conversation between S/A Hunsader and Erica Bowling. Bowling was advised that if any further information came to light that she could contact S/A Hunsader at any time to provide that information. Contact with Bowling terminated at approximately 11:45 a.m.
