On Thursday, November 10, 2005, at approximately 11:55 a.m., S/A Kim J. Skorlinski and S/A Kyra M. Schallhorn, along with Marinette County Sheriff's Department Investigator Todd Baldwin and Corrections Officer Mike Haupt, contacted Allan K. Avery, DOB 05/03/1937, outside his residence at N9493 Highline Lane, Town of Stephenson (Crivitz), Marinette County, to execute a search warrant.

S/A Skorlinski advised Allan that he had a search warrant issued from Marinette County for his DNA and fingerprints and palm prints, and S/A Skorlinski would appreciate his in obtaining these samples. At first, Allan backed away from S/A Skorlinski until S/A Skorlinski told him that if he did not cooperate, S/A Skorlinski would arrest him and transport him to the Marinette County Jail. Allan said he would cooperate, and S/A Skorlinski handed him a copy of the search warrant.

S/A Skorlinski said this is routine in these investigations to eliminate Allan as the source of any DNA or finger prints or palm prints that would be found on the Avery Auto Salvage property. S/A Skorlinski said unlike the other Avery family members who had these samples obtained at a hospital, S/A Skorlinski would like to have Allan give the samples at his residence. Allan said that would be ok. He also asked when is this going to end and when is law enforcement going to leave his son, Steven Avery alone.

S/A Skorlinski then told Allan since he is in custody and not free to leave, S/A Skorlinski would be reading him his Constitutional Rights, in the event that S/A Skorlinski wanted to ask him questions afterwards. S/A Skorlinski then read Allan his Constitutional Rights from a Miranda Warning form provided by the Calumet County Sheriff's Department. S/A Skorlinski paused after reading each right and asked Allan if he understood each right, and he said yes. S/A Skorlinski then read Allan the waiver and asked him if he understood that, and he said yes. S/A Skorlinski then asked Allan to sign the form stating he understood his rights and waiver, but he said he was not going to sign the form. The reading of the rights form started at approximately 11:58 a.m. and completed at approximately 12:00 p.m.

S/A Skorlinski then told Allan that Corrections Officer Haupt would be taking a sample of his DNA by using buccal swabs and would be obtaining his fingerprints and palm prints. S/A Skorlinski asked if C.O. Haupt could use Allan's kitchen table, and he said yes. Allan then accompanied the investigators into his residence. While S/A Schallhorn and C.O. Haupt remained in the kitchen with Allan to obtain the samples, S/A Skorlinski and Inv. Baldwin went outside to speak with Allan's grandson, Brendan Dassey. (This interview will be contained on a separate report.)

At approximately 12:25 p.m., S/A Skorlinski and Inv. Baldwin re-entered the residence to see how the search warrant execution was progressing. S/A Schallhorn advised the DNA sample had been obtained and C.O. Haupt was working on obtaining the fingerprints. S/A Skorlinski then exited the residence to speak with Brendan one more time.

At approximately 12:30 p.m., S/A Skorlinski went back inside the residence and remained there until the search warrant was concluded. The search warrant execution was concluded at

approximately 12:40 p.m. S/A Skorlinski then took custody of the buccal swabs, which had been sealed in two small cardboard boxes, and took custody of the two fingerprint cards and the two palm print cards.

While at the Appleton DCI office, S/A Skorlinski assigned DCI Property Receipt No. C-8455-1 to the two buccal swabs, and C-8456-1 to the two fingerprint cards and C-8456-2 to the two palm print cards. S/A Skorlinski packaged and sealed all of this evidence for transfer to the Wisconsin State Crime Laboratory in Madison. S/A Skorlinski also indicated on the search warrant the buccal swabs were obtained at 12:15 p.m. and the fingerprints and palm prints were obtained at 12:20 p.m. S/A Skorlinski also filled out a search warrant return for the buccal cells and fingerprints and palm prints.

At approximately 4:10 p.m., S/A Skorlinski transferred all of this evidence on Property Receipt No. C-8455 and C-8456 to S/A Schallhorn for transfer to the crime lab in Madison. Upon arriving at the crime lab, Delores Larson received these items and assigned crime lab Item AY to the buccal swabs, Item AZ to the fingerprints and Item BA to the palm prints.

The Miranda Warning form, the search warrant, affidavit, search warrant return and crime lab receipt will be electronically attached to this report, and those documents along with the DCI Property Receipts will be forwarded to DCIR.
