On Friday, November 11, 2005, S/A Alan S. Hunsader was assisting with an investigation into the disappearance of Teresa Marie Halbach. On this date, S/A Hunsader was assisting with the investigation on the property of the Avery family in Manitowoc County, WI. While at this location, S/A Hunsader received an assignment to search specific vehicles on the property. The following is a summary of those searches:

At approximately 12:27 p.m., S/A Hunsader searched a blue/green colored Chevrolet Malibu, four door, bearing WI license UDY970. This vehicle was parked in the garage of the residence belonging to Delores A. and Allen K. Avery. Subsequent to searching this vehicle, S/A Hunsader located two handwritten notes in the backseat of the driver's side on the floor. One of these notes said "16 St. TR," the other said "9x12". Also located in the back seat of the vehicle in the cup holder in the center console, left side, was a glass pimento jar, capped and containing a white powder substance. All three of the aforementioned items were turned over to evidence technicians for collection. Also located in the vehicle were various articles, to include wrappers, napkins, a cane, newspapers and various other items not considered to be of evidentiary value at this time. In the glove compartment, S/A Hunsader observed documentation to include an insurance card for American Family listing to Allen K. Avery, 12930 Avery Road, TR, and registration form for Delores A. or Allen K. Avery, 12930 Avery Road, Two Rivers. This inspection included the entire passenger compartment, trunk, under the hood, and the fueling compartment. This search concluded at approximately 12:45 p.m.

At approximately 1:05 p.m., S/A Hunsader arrived in the garage adjacent to the trailer belonging to Barbara Janda, sister of Steven Avery. Within this garage, S/A Hunsader noted a deer carcass hanging from a framed assembly and, adjacent to the deer carcass, a yellow Bombardier four-wheeler, further described as a 4x4 Outlander, 400cc, bearing registration 8097093, expiration 2007. A subsequent search of this ATV yielded nothing of evidentiary value.

S/A Hunsader also examined what appeared to be a disassembled tree stand, located on the floor of that garage adjacent to the deer carcass and the four wheeler. This examination also yielded nothing of evidentiary value.

S/A Hunsader conducted a cursory search of items within this garage. This search yielded nothing of evidentiary value. The search concluded at approximately 1:10 p.m.

Shortly after concluding the search of the Janda garage, S/A Hunsader searched a blue Chevrolet Impala, four door, WI license 586JMC, located in the office of Chuck Avery. This search also yielded no items of evidentiary value, however, S/A Hunsader did locate a piece of a paper with a handwritten telephone number. This piece of paper was located above the sun visor of the driver's front side. The telephone number written on this piece of paper was 652-0124.

No damage was caused to any of the aforementioned vehicles or any of their contents as a result of these searches.

S/A Hunsader also assisted S/A Matthew Joy with a search of a 1998 Eagle Talon, located in front of Barbara Janda's residence. For additional details regarding that search, see S/A Joy's

report. Additionally, a yellow Dodge Neon was searched by S/A Lou Ojeda. For additional details regarding that search, see S/A Ojeda's search.

Upon concluding these searches, the blue Chevrolet Impala and the blue/green Chevrolet Malibu were released to members of the Avery family. For additional details regarding the release of these vehicles to these family members, see S/A Kim Skorlinski's report.
