On November 6, 2005, S/A Kevin L. Heimerl and S/A Lisa Wilson assisted with the investigation of the missing person Teresa Marie Halbach in the Town of Gibson, Manitowoc County, WI. S/A Heimerl and S/A Wilson conducted a neighborhood canvas of the area surrounding State Highway 147 and Avery Road.

On November 6, 2005, at approximately 2:30 p.m., S/A Heimerl and S/A Wilson made personal contact with several subjects present at 3434 STH 147, Two Rivers. This residence is located approximately one-quarter mile west of the intersection of STH 147 and Avery Road. Investigators met with Therese A. Kudick, W/F, DOB 12/11/1960, who resides at 3434 STH 147, Two Rivers, 920-755-4281. Also present at the residence was Therese Kudick's sister, Jean M. Andrus, W/F, DOB 01/06/1963, who has been residing at this address for approximately two months. Also present was Therese Kudick's boyfriend, Steven R. Hiers, W/M, DOB 06/29/1964, who resides at W2696 CTH O, Sheboygan Falls, WI 53085, 920-467-8455. Investigators also spoke with Kyle S. Kudick, W/M, DOB 03/28/1984, cell phone 920-901-6614, the son of Therese Kudick, who arrived home at the residence a short time later.

Investigators spoke with these individuals jointly and asked if they were aware of the investigation occurring in their neighborhood, and they stated they were. Investigators asked if these subjects had seen media coverage to include pictures of the missing female and her vehicle. All subjects stated that they had seen pictures of the missing female and her vehicle. All subjects stated that they had not seen that female or her vehicle in the area. Therese Kudick stated that she and her boyfriend, Steve Hiers, were in Sheboygan Falls on Friday evening and arrived at her residence on Saturday to discover the law enforcement activity. Investigators inquired as to whether or not any of these subjects had made any observations or discovered anything on their property which they felt was potentially related to this investigation, or had made any observations which they felt were out of the ordinary for their neighborhood during the course of the previous week. All subjects stated they had not observed anything unusual, nor did they feel they had any information related to the investigation.

Investigators asked if the subjects were familiar with the Avery family or the Avery salvage business. Therese Kudick stated she has not had any contact with the Averys since she has resided in this neighborhood. Therese Kudick stated she had spoken with her son, Kyle Kudick, who is employed at Mishicot Auto Sales. She stated she was told by her son, Kyle, that Kyle did recognize the missing female and believed that she had at some point stopped in at Mishicot Auto Sales. Therese Kudick further stated that she believes her son, Kyle Kudick, is familiar with the Avery family.

Prior to leaving the investigators leaving the residence, Kyle Kudick did arrive home. Investigators spoke briefly with Kyle Kudick. Kyle Kudick stated that he has seen pictures of the missing female and her vehicle through media coverage, and stated that he has not seen that female or her vehicle in the neighborhood. Kyle Kudick stated he had not made any observations in the neighborhood which he felt were out of the ordinary during the course of the previous week. Kyle Kudick stated that he is employed at Mishicot Auto Sales and stated that he participates in amateur racing and stated the Averys have sponsored his race car in the past. Kudick stated he was last at Avery's business approximately one year earlier.

Kyle Kudick stated that on Friday, 11/04/2005, he saw Earl and Chuck Avery while he was at Mishicot Auto Sales. He stated that Chuck and Earl were picking up junked cars. He stated he believed that Earl was at the business for a couple of hours picking up the junked cars. Kyle Kudick was asked if he had seen Steven Avery at all during the previous week and he stated that he had not.

Kyle Kudick was asked if he had ever met the missing female, Teresa Halbach, and he stated he had never met her, however, he stated he had seen her in the past. Kyle Kudick further stated that Kathy, who is an employee at Mishicot Auto Sales, and Gordy Kudick, who is the owner of the business, both informed him that they know the female Teresa Halbach. Kyle Kudick was unable to provide any further information.
