On November 7, 2005, S/A Kevin L. Heimerl and S/A James A. Sielehr assisted with the investigation of the missing person, Teresa Marie Halbach, in the Town of Gibson, Manitowoc County, WI. S/A Heimerl and S/A Sielehr conducted a neighborhood canvas of the area surrounding STH 147 and Avery Rd.

On November 7, 2005, at approximately 8:30 a.m., S/A Heimerl and S/A Sielehr made personal contact with Donald H. Hagenow, M/W, DOB 05/03/1938, who resides at 12604 Jambo Creek Rd., Two Rivers, WI, 920-755-4753. Hagenow resides at this residence alone.

Investigators asked Hagenow if he had seen recent media coverage of the missing female and her vehicle from Calumet County. Hagenow stated that he had seen pictures of the female and her vehicle and stated that he had not seen the female or her vehicle in the area.

Hagenow was asked if he had made any observations of unusual activity or made any observations of any activity that he felt may potentially be related to this investigation during the course of the previous week. Hagenow stated that he had not observed anything abnormal and had not made any observations that he felt was related to the investigation. Hagenow's residence is located directly east of the Avery property.

Hagenow was asked if he was familiar with the Avery family or the Avery Salvage business. Hagenow stated that he was familiar with the Avery business and stated that he was last at the business approximately one to two months earlier when he had purchased a battery from Avery's. Hagenow stated that he had walked through his property and had not found anything that he felt did not belong on his property.
