On November 7, 2005, S/A Kevin L. Heimerl and S/A James A. Sielehr assisted with the investigation of the missing person, Teresa Marie Halbach, in the Town of Gibson, Manitowoc County, WI. S/A Heimerl and S/A Sielehr conducted a neighborhood canvas of the area surrounding STH 147 and Avery Rd.

On 11/07/2005, at approximately 3:30 p.m., S/A Heimerl and S/A Sielehr made contact with Jeffery A Springstube, M/W, DOB 05/08/1990, who resides at 13136 White Cedar Road, Two Rivers, Manitowoc County, WI 54241, 920-755-4665. Jeffery resides at this residence with his father, Wesley S Springstube, M/W, DOB 03/05/1957, 920-755-4665, cell phone: 920-371-3877; his sister, Jessica A Springstube, 15 years old; his cousin, Johnny J Springstube, 14 years old; and his cousin, Shaun M Springstube, 12 years old. During the course of this interview, investigators wished to speak with Springstube concerning any observations related to the neighborhood canvas, as well as to attempt to identify a young female who was seen at the Richmond residence, on Kuss Rd., on the evening of 11/04/2005.

Investigators spoke with Jeffery Springstube, who stated that his father was not present at the residence at the time of interview. Investigators asked Springstube if he had seen recent media coverage of the missing female and her vehicle from Calumet County. Jeffery Springstube stated that he had seen the media coverage and had seen pictures of the female and her vehicle. Springstube stated that he had not seen that female or her vehicle in the area. Investigators asked Springstube if he had seen anything unusual occur in the area during the course of the previous week, which was potentially related to the investigation. Springstube stated that he had not seen anything unusual during the course of the previous week.

Investigators asked Springstube if he was home at his residence on the evening of Friday, 11/04/2005. Springstube thought about it for a moment and stated that he believed that he spent that evening at his friend's residence and was not home at his residence. Investigators asked Springstube if he knew if a young female had stopped at his residence on that evening to possibly visit one of his siblings or one of his cousins. Springstube stated that he did not know if a female would have stopped at his residence on that evening and had not heard as to whether or not any young women had stopped at his residence on that evening. Jeffery Springstube provided no further information.
