On November 7, 2005, S/A Kevin L. Heimerl and S/A James A. Sielehr assisted with the investigation of the missing person, Teresa Marie Halbach, in the Town of Gibson, Manifowoc County, WI. S/A Heimerl and S/A Sielehr conducted a neighborhood canvas of the area surrounding STH 147 and Avery Rd.

On 11/07/2005, at approximately 3:45 p.m., S/A Heimerl and S/A Sielehr conducted an interview with Stanley J Junk, M/W, DOB 06/20/1956, who resides at 13211 White Cedar Road, Two Rivers, Manitowoc County, W1 54241, 920-755-4880, and 920-755-4835. Yunk resides at this residence with his wife, Theresa J Krueger-Junk.

Investigators asked Yunk if he had seen recent media coverage concerning the missing female and her vehicle from Calumet County. Yunk stated that he has seen the media coverage. Yunk was asked if he had seen pictures of the female and her vehicle and he stated that he has. Yunk stated that he has not seen that female or her vehicle in the area.

Investigators asked Yunk if he had seen anything out of the ordinary or unusual or anything that he felt was potentially related to this investigation during the course of the previous week. Yunk stated that he had not seen anything unusual or potentially related to this investigation during the course of the previous week.

During the course of the interview with Yunk, Yunk stated that often times during the evening he will sit in his living room of his residence with the windows facing to the east. When in Yunk's living room, this view provides an opportunity to view the area of the Avery property, to include the northwest corner of the Avery property near Steven Avery's residence. S/A Heimerl had an opportunity to stand in the living room and look in that direction and observed that there was some tree line partially obscuring the area. S/A Heimerl asked Yunk if he was able to see headlights of vehicles during the evening, which may be operating around the Avery property. Yunk stated that it is not uncommon for him to see headlights sweeping past his windows during the evening hours as late as 10:00 p.m., when he normally goes to bed. Yunk stated due to the distance, he is not able to determine where on the Avery property the vehicles are but believes that the headlights travel down the access road from the end of Avery Rd., towards the Steven Avery residence. Yunk stated that as the vehicles turn, the headlights during the evening hours, he does not consider it unusual, therefore, he does not pay any particular attention to dates and times of when he observes these vehicles. Yunk provided no further information.
