On November 7, 2005, S/A Kevin L. Heimerl and S/A James A. Sielehr assisted with the investigation of the missing person, Teresa Marie Halbach, in the Town of Gibson, Manitowoc County, WI. S/A Heimerl and S/A Sielehr conducted a neighborhood canvas of the area surrounding STH 147 and Avery Rd.

On 11/07/2005, at approximately 4:00 p.m., S/A Heimerl and S/A Sielehr conducted an interview of five members of the Vander Warf family, who reside at 4183 Kuss Road, Two Rivers, Manitowoc County, WI 54241, 920-755-8856. The subjects interviewed included the father, Todd A Vander Warf, M/W, DOB 03/21/1964, his wife, Kari L Vander Warf, F/W, DOB 10/20/1964, and their three daughters, Amanda L. Vander Warf, F/W, DOB 04/10/1987, Kelsi J Vander Warf, F/W, DOB 01/13/1991, and Rebecca E Vander Warf, F/W, DOB 07/23/1992.

At the time of this interview, an extensive evidence search was occurring on property owned by the Vander Warf's at the end of the cul-de-sac of Kuss Rd.

The Vander Warf's stated that they have resided at this residence for approximately three years. They stated that they do own property, to include a wooded area to the east of their residence with this property including approximately five acres. They stated that they own the property from their residence to the east along the south side of Kuss Rd., to the end of Kuss Rd., where a dirt two track travels along a large dirt berm and with this dirt track leading back to the Radant property.

The Vander Warf's stated that normally during weekdays, nobody is at home at their residence as both parents are working and the children are in school. Investigators asked if any of the Vander Warf's observed anything unusual occur in the neighborhood during the course of the previous week or if they discovered anything abnormal on their property during the course of the previous week. The Vander Warf's stated that they did not observe anything out of the ordinary. The Vander Warf's stated that they did see pictures of the missing female and her vehicle on local media coverage. The Vander Warf's stated that they did not see that female or her vehicle in the area.

Kari Vander Warf stated that on a nearly daily basis in the afternoon hours after work she will take the family dog for a walk through the wooded area on their property, to include a small meadow area at the end of Kuss Rd., where the search was presently taking place. Kari Vander Warf stated that she has not observed anything unusual in the past in that area. The Vander Warf's provided no further information.
