On November 7, 2005, S/A Kevin L. Heimerl and S/A James A. Sielehr assisted with the investigation of the missing person, Teresa Marie Halbach, in the Town of Gibson, Manitowoc County, WI. S/A Heimerl and S/A Sielehr conducted a neighborhood canvas of the area surrounding STH 147 and Avery Rd.

On 11/07/2005, at approximately 4:30 p.m., S/A Heimerl and S/A Sielehr conducted an interview of Diane M Turk, F/W, DOB 10/04/1960, who resides at 13011 White Cedar Road, Two Rivers, Manitowoc County, WI 54241, 920-755-2449. Diane Turk stated that she resides at this residence with her husband, Stephen E Turk, M/W, DOB 11/21/1956, and her son, Jacob R Turk, M/W, DOB 04/19/1983.

Investigators asked Diane Turk if she had seen recent media coverage of the missing female and her vehicle from Calumet County. Diane Turk stated that she had seen the media coverage. Investigators asked if she had seen pictures of the missing female and her vehicle and she stated that she had. Diane Turk stated that she has not seen that female or her vehicle in the area. Diane Turk also offered that she is originally from the Hilbert, WI, area and she does know the parents of Teresa Halbach. Diane Turk stated that there was normally nobody home at her residence during the day as she and her husband both work and her son is in school.

Investigators asked Diane Turk if she observed anything unusual in her neighborhood during the course of the previous week and also if she had observed any unusual vehicular or foot traffic on Kuss Rd., during the previous week. Diane Turk stated that she only saw the normal in and out traffic on Kuss Rd., and White Cedar Rd.

Investigators asked Diane Turk if she or family is familiar with the Avery family or the Avery Salvage business. Diane Turk stated that her husband has gone to the salvage area in the past; however, she stated that she believed that it has been some time since her husband had been there. Investigators asked Diane Turk if anyone stopped at her residence during the late evening hours on Friday, November 4, 2005. Diane Turk stated that they did not receive any visitors at their residence late on that evening. Diane Turk provided no further information.
