On Thursday, 11/10/2005, at approximately 7:00 p.m., S/A James C. Holmes and S/A Thomas A. Sturdivant met Calumet County Sheriff's Investigator John Dedering in Hilbert, Wisconsin at a location along County Highway B. At that time, Investigator Dedering provided S/A Holmes with several items that were believed to belong to TERESA M. HALBACH (DOB: 03/22/1980).
