On Friday, 11/11/2005, at approximately 1:50 p.m., S/A James C. Holmes met with Dane County Deputy Coroner Colleen Little at the Dane County Morgue in Madison, Wisconsin. S/A Holmes and Dr. Leslie Eisenberg, a forensic anthropologist, had arranged for S/A Holmes to drop off evidentiary items, believed to be bone material, that law enforcement officers had obtained from a charred pile of material located at the Calumet County Sheriff's Department, and from in and around a burn pit located to the south of STEVEN AVERY'S mobile home trailer and detached garage at the Dane County Morgue. (See DCI report number 05-1776/68 which pertained to S/A Holmes' actions in transporting the bone material to the Dane County Morgue). Dr. Eisenberg planned to examine the aforementioned bone evidence at a later time.

Dr. Eisenberg and S/A Holmes also arranged for S/A Holmes to obtain dental structures that Dr. Eisenberg had separated from evidence that she had already examined. S/A Holmes was to transport the aforementioned dental structures from the Dane County Morgue to Dr. Donald Simley, a forensic odontologist. S/A Holmes collected one plastic baggie containing dental structures from Deputy Coroner Colleen Little. S/A Holmes placed the plastic baggie containing dental structures onto DCI property receipt #D6257. (See DCI report number 05-1776/68 which pertained to S/A Holmes' collection of the plastic baggie that contained the dental structures).

On 11/11/2005, at approximately 2:30 p.m., S/A Holmes met with Dr. Donald Simley at his dental office located at 2037 Winnebago Street, Madison, Wisconsin. Dr. Simley took possession of the aforementioned dental structures from S/A Holmes at that time. Dr. Simley was to examine and compare the dental structures to TERESA M. HALBACH's (DOB: 03/22/1980) dental records.

A copy of DCI property receipt #D6257 will be included in the case file.
