From November 5 thru 8, 2005, S/A Kevin L. Heimerl assisted with the investigation of the missing person Teresa Marie Halbach, in the Town of Gibson, Manitowoc County, WI.

On 11/08/2005, in the late afternoon hours, S/A Heimerl remotely checked his office voice mail and retrieved a voice mail message, which was left in the voice mail system on 11/08/2005 at 1:17 p.m. The voice mail message is from a caller who was unidentified and appears to be a female voice. The voice mail message which was left states verbatim, "I heard that on Friday, November 4th 7am Joe Mott and David Krueger went to Avery's salvage and were told to leave by Steve and Earl because they were going to melt aluminum. They seemed anxious and scared waiting and Joe and David had to leave immediately. Thank you. Check it out."

On 11/09/2005, at 7:35 a.m., S/A Heimerl and S/A Joseph M. Kapitany conducted an interview of David H. Krueger, W/M, DOB 01/14/1964, at his residence of 410 Greenmeadow Drive, Apartment 25, Reedsville, WI. Investigators meet with Krueger at his apartment and spoke with Krueger in his apartment. No one else was present at the time of the interview.

Investigators informed Krueger that they were assisting in the investigation of the missing person Teresa Marie Halbach and a possible relationship to Avery's Auto Salvage, located on STH 147, in the Town of Gibson, Manitowoc County, WI. Investigators informed Krueger that they had received information which indicated that Krueger and a friend may have been at Avery's business during the first week of November, 2005. David Krueger provided the following information:

Krueger stated that he and a friend, Joe Mott, were at Avery's salvage business approximately two weeks earlier. He stated that, on a date he could not specifically recall, he and Joe Mott were at Avery's salvage business attempting to remove a steering wheel from a 1957 Buick Special, which was purple and yellow in color. During the early stages of the interview, Krueger indicated that he is aware that his friend, Joe Mott, goes to Avery's salvage business on a frequent basis. During further questioning, Krueger stated that he and Mott were possibly at Avery's during the previous week and, after further questioning, he recalled that he and Mott were possibly at Avery's salvage yard on Friday, 11/04/2005 at approximately 2:00 or 2:30 p.m. Krueger stated he now recalled that, while at Avery's salvage business on Friday, 11/04/2005, he saw Steve Avery in the new shop and Steve was doing something near the waste oil heater. Krueger further stated that he recalled that Chuck Avery was present and Earl Avery was also present. He stated Earl was dropping off cars at the business with the "roll back" or the flatbed tow truck. Krueger stated when he and Mott initially arrived at Avery's salvage business, Mott spoke to Steve and Earl. Krueger stated he and Mott then went down into the salvage yard and went straight south of the red colored shed. Krueger stated that he ultimately removed a bolt from a vehicle to be used on one of his vehicles. Krueger also stated that he and Mott were in the shop area after being in the yard, and obtained used anti-freeze, which had waste oil mixed with it that they needed to separate.

Krueger stated that, while at the Avery salvage business, he did not see any fires burning. He stated he believed that the total amount of time he and Mott were at the business was
