On November 11, 2005, at approximately 11:50 a.m., S/A Thomas A. Sturdivant interviewed Travis P. Groelle, W/M, DOB 05/28/1983, who works for F. Radandt Sons Inc. as a hopper loader and was working on Monday, 10/31/2005 at the pit on CTH Q. Groelle provided his home address as 4902 CTH B, Manitowoc, WI, 920-684-4028.

Groelle stated he worked from 4:00 a.m. until noon and then from 4:30 p.m. to 7:00 p.m., on Monday, 10/31/2005. Groelle stated he was running the hopper and operating the loader throughout the day and evening. Groelle stated it was after 5:30 or 6:00 p.m. that he smelled a foul odor coming from the Avery salvage yard area. Groelle stated he could not see a fire or smoke, as it was dark outside, and described the odor as something that "I never smelled before." Groelle distinctly recalled that it was Monday, Halloween night that he was working, and that he normally doesn't work at night. The wind was blowing towards the pit from the Avery property. Groelle stated he mentioned this foul odor to two other employees: Chris Peterson, who can be reached at 920-755-2082; and David Treml, nicknamed "Cuba," who can be reached at 920-593-2951.

The interview with Groelle was concluded at 12:00 noon.
