Narrative begins on the following page.

On Monday, November 14, 2005, at approximately 2:30 p.m., S/A Kim J. Skorlinski and Investigator Wendy Baldwin, of the Calumet County Sheriff's Department, contacted Robin L. Weber, W/F, DOB 06/11/1963, at her place of employment, Intimate Treasures (an adult novelty store), 1507 W. Washington Street, Manitowoc, 920-769-0008, regarding this investigation. Weber is the manager of Intimate Treasures and resides at 620 S. 8th. Street, Apt 310, Sheboygan..

The investigators advised Weber that they believed within the last couple of months Steven Avery and his sister, Barb Janda, purchased items from Intimate Treasures, such as leg cuffs and handcuffs. The investigators asked if Weber would be able to obtain a copy of the receipts for those purchases. Weber asked if either Steven or Barb paid with a credit card or check, and the investigators did not know that. She said it would be easier to determine when the purchase was made if they paid with a credit card or check. Weber said she would try to determine if there was a cash purchase within the last two months for these items.

Weber took several leg cuff and handcuff packages off the display and scanned the barcode on the packages to determine when the last purchases were made. Weber found two receipts: one Invoice #14089 for a purchase on 10/09/2005 at 2:53 p.m. for one teras animal print cuff for \$17.25 and a furry leg cuff zebra for \$28.75, for a total with tax of \$48.30. She said this was a cash purchase. Weber said a second Invoice #14090 dated the same, 10/09/2005 at 2:55 p.m. indicates a purchase of two furry leg cuffs pink for \$28.75 each and a bottle of liquid love strawberry for \$7.50, for a total with tax of \$68.25. She said this was also a cash purchase. The investigators told Weber they believed these were the receipts for Steven and Barb. Weber then provided S/A Skorlinski with copies of the receipts.

Weber advised that even though her name appears on the receipt as the cashier, one of her employees, Dawn Lehr, was actually the employee who sold these items. Weber said Lehr lives in Manitowoc, phone 920-683-1340. Weber then tried calling Lehr, but did not receive an answer. The investigators asked Weber to continue to try to contact Lehr and advise her that the investigators would like to speak to her to about these purchases. Weber said she would do that.

On Tuesday, November 15, 2005, at approximately 11:30 a.m., S/A Skorlinski and Investigator Baldwin returned to Intimate Treasures, after receiving information from the Manitowoc County Sheriff's Department that Weber had left a message for the investigators.

Weber said she did speak with Lehr, who stated that the male and female couple who came into Intimate Treasures to purchase the leg cuffs and handcuffs, walked directly to the display wall where the cuffs were located. Weber said Lehr stated that they picked out the ones they wanted, made the purchase and left. Weber said according to Lehr, they did not browse around the store but were in and out in a few minutes. Weber said the reason Lehr remembered this is because it is rare that they sell three leg cuffs and handcuffs at one time.

S/A Skorlinski asked Weber if Lehr mentioned that the male looked familiar from all the media reports relating to the murder of Terersa Halbach. Weber said Lehr did not say anything about

the male being the same guy on TV, and she did not give a description of him. However, Weber said Lehr described the female as being skinny and looking like a "crack whore."

On Thursday, November 17, 2005, S/A Skorlinski assigned DCI Property Receipt No. C-8458-1 to the receipt for the animal print cuffs and leg cuffs for \$48.30, believed to be purchased by Steven; and C-8458-2 to the two leg cuffs and strawberry liquid love for \$68.25, believed to be purchased by Barb.

The receipts from Intimate Treasures will be electronically attached to this report, and copies of those receipts and the DCI property receipt will be placed into the case file.
