The third page of this facsimile is titled Wisconsin Online License Files (WOLF) Customer Approval Sales List. This page lists the hunting/fishing licenses obtained by Steven Avery; Customer ID No: 512509803, for the 2005 calendar year.

This page indicates that on August 19, 2005, Avery obtained a Hunter's Choice Permit as the result of a DNR special permit drawing. On July 31, 2005, Avery obtained a Resident Gun Deer Permit, an Antlerless-Zone T permit, and a Hunter's Choice Application from Mills Fleet Farm, in Manitowoc, WI.

On July 2, 2005, Avery obtained an Annual Fishing Permit from the Tall Oaks General Store.

Page four of the facsimile is titled Wisconsin Online License Files (WOLF) Customer Approval Sales List. This page lists the licenses obtained by Steven Avery; Customer ID No: 512509803, for the 2004 calendar year. This document indicates on November 19, 2004, Avery obtained a Resident Gun Deer Permit and an Antlerless Zone T Permit from the Mobil 310 Mart.

On May 1, 2004, Avery obtained a Resident Annual Fishing Permit and a Salmon/Trout Stamp from the Wal-Mart Store.

The fifth and final page of the facsimile was titled Wisconsin Online License Files (WOLF) Customer Approval Sales List. This page lists the hunting and fishing licenses obtained by Steven Avery; Customer ID No: 512509803, for the 2003 calendar year. This page indicates that

on November 12, 2003, Avery obtained a Gun Deer Permit and an Antlerless Zone T Permit from the Mills Fleet Farm, in Manitowoc.

On October 4, 2003, Avery obtained an Annual Fishing Permit and a Salmon/Trout Stamp from the Mills Fleet Farm, in Manitowoc.
