On Thursday, November 17, 2005, S/A Debra K. Strauss contacted a representative from Mills Fleet Farm, 1235 S Rapids Rd., Manitowoc, WI, 920-682-4403. S/A Strauss advised the representative of Mills Fleet Farm that she was requesting a copy of the receipt signed by Seven Avery, on July 31, 2005. More specifically, S/A Strauss was requesting a copy of the receipt Avery signs when he obtained his Gun Deer Permit, Hunter's Choice Application and Antlerless-Zone T Permit, on July 31, 2005.

Later that day, S/A Strauss received a two page facsimile. The first page is a cover page from Diane M to Deb Strauss. Written on the coversheet indicates a copy of the signature slip had been requested. At this time, Fleet Farm cannot let the original receipt leave the premises. However, S/A Strauss was provided with a copy of the receipt signed by Steven Avery.

By signing this receipt, Avery certifies that he is a Wisconsin resident and has maintained a permanent residence in Wisconsin for the previous thirty days and that his privileges are not otherwise revoked. This slip also states that by signing the document, Avery understands that a hunting license issued by the Department of Natural Resources does not authorize the possession of a firearm by a felon or anyone who cannot possess a firearm due to a conviction for a crime of domestic violence.

This document states that the signatory has read the statement above and has complied with all of the laws regulating the issuance and purchase of this license, and the his privileges are not otherwise revoked.

This document appears to have been signed by Steven Avery on July 31, 2005.
