On Thursday, November 20, 2005, at approximately 6:58 p.m., S/A Lisa A. Wilson interviewed Emily A. Walker, DOB: 06/07/1987, in the lobby of the Two Rivers Police Department. Walker is the girlfriend of Bryan J. Dassey, DOB: 07/15/1985. S/A Wilson explained to Walker that S/A Wilson would be asking her about her activities and interaction with Bryan J. Dassey, DOB: 07/15/1985, on Monday, October 31, 2005, Halloween.

Walker said she arrived home from work at approximately 5:30 p.m., just after trick-or-treating had started. Walker said that she lived with her parents. Approximately five to ten minutes after she arrived home, Walker said she used her cell phone to call Bryan to tell him she was home from work. Walker said that she had started a new job at a retail store that day.

S/A Wilson asked Walker how long it took to drive from Bryan's residence to her residence. Walker said it was approximately 20 minutes. S/A Wilson asked Walker what she and Bryan did Halloween night. Walker said she and Bryan just stayed at her residence. S/A Wilson asked Walker if she recalled what Bryan was wearing that night. Walker said she couldn't specifically recall, but said he usually wears blue jeans and some type of shirt and his Chevy racing jacket.

S/A Wilson asked Walker if Bryan stayed over at her house that night. Walker said Bryan had stayed over at her house that night and that lately, he's been staying over there a lot. Walker said Bryan usually goes right to work from her house in the morning. Walker said Bryan used to carpool with his mother, Barb Janda, but was no longer doing so since spending most of his nights at her place.

The interview with Walker was concluded at approximately 7:05 p.m.
