On November 7, 2005, at approximately 11:15 a.m., S/A Kim J. Skorlinski assisted the Wisconsin State Crime Laboratory and the Marinette County Sheriff's Department with the search of a red 2005 International Harvester flatbed tow truck, WI license GD27469, registered to Charles E. Avery and Earl K. Avery, d/b/a Avery's Auto Salvage, 12928 Avery Road, Two Rivers. This vehicle was searched at the Marinette County Sheriff's Department.

During the search of this vehicle, S/A Skorlinski utilized a Canon Sure Shot 60 Zoom, using 200 speed film, and took nine photographs of this vehicle and two photographs of a second vehicle, a blue 1993 Pontiac Grand Am, WI license 187JJF, registered to Steven Avery, 12930 Avery Road, Two Rivers. This vehicle had also been seized pursuant to the same search warrant.

The photos were subsequently developed and on Friday, December 9, 2005, S/A Skorlinski picked up the four sets of photos. S/A Skorlinski then filled out a DCI Field Photo Log for the eleven photos. The four sets of photographs will be provided to the investigators and the attorneys in this case. The negatives will be placed in the case file in DCIR.

The Field Photo Log will be electronically attached to this report and a copy will be placed into the case file.
