On Wednesday, November 9, 2005, during the evening hours, Investigator Mark Wiegert, of the Calumet County Sheriff's Department, gave a search warrant to S/A Thomas J. Fassbender and asked that S/A Fassbender execute the search warrant on Thursday, November 10, 2005. Said search warrant was for Avery's Auto Salvage, 12930 Avery Road, in the Town of Gibson, Manitowoc County, WI, including four residences also located on that property, i.e. Delores and Earl Avery, 12930 Avery Road; Charles Avery, 12928 Avery Road; Steven Avery, 12932 Avery Road; and Barbara Janda, 12930A Avery Road. Sheriff Jerry Pagel obtained said search warrant on November 9 and he was the affiant for the affidavit for search warrant. This search warrant was obtained because it was anticipated that the search was going to take up to several more days. The initial search warrant for this property was obtained and executed by the Calumet County Sheriff's Department, the details of which will be documented in their reports.

During the morning hours of Thursday, November 10, 2005, S/A Fassbender executed the search warrant at Avery's Auto Salvage and said residences.

On Friday, November 11, 2005, at approximately 8:15 a.m., S/A Fassbender entered the residence of Barbara E. Janda, 12930A Avery Road, in the Town of Gibson, Manitowoc County, WI, and left a copy of said search warrant on a table within that residence. After leaving the search warrant copy on the table, S/A Fassbender exited the residence.

The return for search warrant was prepared by Investigators Wiegert and John Dederling of the Calumet County Sheriff's Department. It was filed by Inv. Dederling with the Manitowoc County Clerk of Circuit Court on November 14, 2005. Details of the search and items seized will be documented in reports and receipts prepared by both DCI and the Calumet County Sheriff's Department as well as others involved in the searching.
