On Friday, November 11, 2005, at approximately 10:20 a.m., S/A Thomas J. Fassbender had telephone contact with Barbara Janda. During that contact, Janda advised that someone was following her husband, Tom Janda. She advised the person following him was in a teal colored car.

Janda asked if the investigators had checked on that woman who saw Teresa Halbach's car. Janda was referring to information that a woman had allegedly seen Halbach's vehicle after 10/31/2005. S/A Fassbender informed Janda that he had people following up on that, as well as the girl that Steven Avery had told investigators about, in reference to information that a cop had put the vehicle on the Avery property. S/A Fassbender also told Janda that someone would be interviewing Tom Janda.

Also during the conversation, Janda made several requests of S/A Fassbender, to include getting personal items from the Avery property to include Bobby Dassey's ATV and deer stand ladder and Bryan Dassey's car, as well as other family members' vehicles. S/A Fassbender agreed to make arrangements for the return of some items, but also requested an opportunity to talk to Janda and her brothers, Earl and Chuck Avery. S/A Fassbender told Janda that they did not have to answer any questions, but requested that they just listen to investigators. Janda did agree to that and investigators ultimately met with them. Details of those contacts are documented in separate reports.

Family members were allowed to obtain items, to include the ATV and Chuck Avery's vehicle. S/A Fassbender continued to work with the Averys reference their concerns about items taken, including a skid steer and business records. S/A Fassbender had copies made of the business records and ultimately had copies returned to Allan Avery through S/A Skorlinski. The skid steer ultimately was returned through the Calumet County Sheriff's Department.
