On Thursday, November 10, 2005, from approximately 9:28 a.m. to 9:42 a.m., S/A Thomas J. Fassbender and Investigator Wendy Baldwin, of the Calumet County Sheriff's Department, entered the unattached garage adjacent to Steven Avery's residence. They did so because the investigators had received information from one of the previous searches that they had observed a folded or rolled up license plate in the garage.

Upon looking through the garage, the license plate on the front of the Suzuki Samurai that was in the garage was bent or rolled up from the bottom toward the top. It appeared that the plate had been damaged by the front end of the vehicle running into something.

S/A Fassbender and Inv. Baldwin also looked for any obvious tire impressions on the floor. They did locate one possible impression but felt it was too light to photograph.

Also on that date, S/A Fassbender located a skid steer in the Avery salvage yard shop. S/A Fassbender noted that the bucket was not attached to the skid steer but rather was sitting next to it. S/A Fassbender visually examined the bucket and did not observe any apparent evidence such as material that appeared to be blood or trace material such as hair. S/A Fassbender did measure the width of the bucket for the purpose of comparing that to the width of the burn pit located directly behind the garage next to Steven Avery's residence. S/A Fassbender ultimately made that comparison and found that the widths were essentially the same.
