On Friday, November 11, 2005, at approximately 3:05 p.m., S/A Thomas J. Fassbender and Investigator Mark Wiegert, of the Calumet County Sheriff's Department met with Karen Halbach, DOB 11/07/1956, at her residence, 3559 CTH B, Hilbert, WI, 920-989-1098. Karen Halbach is the mother of Teresa Halbach. Also, at the residence was Tim Halbach, DOB 01/10/1979, the brother of Teresa Halbach. Karen Halbach had been previously contacted and advised that S/A Fassbender and Investigator Wiegert were going to stop by for the purpose of obtaining a buccal cell sample from both Karen and Tim Halbach. It had been explained to them that the samples would be transported to the Wisconsin State Crime Laboratory and used in an attempt to establish a DNA profile standard for Teresa Halbach.

While at the Halbach's residence, S/A Fassbender used cotton swabs to obtain two buccal cell samples from both Karen and Tim Halbach.

S/A Fassbender and Investigator Wiegert left the Halbach residence at 3:10 p.m. Investigator Wiegert receited the buccal cell samples as evidence and they were transferred to S/A Lisa Wilson, who subsequently transferred them to the Wisconsin State Crime Laboratory, in Madison.
