On Monday, 12/19/2005, and Tuesday, 12/20/2005, Special Agents from the Division of Criminal Investigation searched evidence consisting of ash, soil, and burned material that law enforcement officers had previously obtained from a burn pit located on STEVEN A. AVERY'S (DOB: 07/09/1962) property at 12932 Avery Road, Two Rivers, Wisconsin. The material that had been searched on 12/19/2005 was documented under Calumet County Sheriff's Department's item #7923 and listed as brown tarp with burn material. The material that had been searched on 12/20/2005 was documented under Calumet County Sheriff's Department's item #7947 and listed as burned material (south of dugout) wrapped in tarp. The search of the aforementioned items took place at the Wisconsin Crime Laboratory in Madison, Wisconsin. Forensic Anthropologist, Dr. Leslie Eisenberg, assisted in the search of the aforementioned items on 12/19/2005. Calumet County Deputy Rick Riemer maintained custody of the aforementioned evidentiary items that were searched on both days.

It should be noted that new tarp material was placed under three work tables that were set up to conduct the search of the aforementioned evidentiary items. The tarp materials were collected after the search was completed on Tuesday, 12/20/2005, and placed with Calumet County Sheriff Department's property #7947.

Deputy Rick Riemer created two separate Calumet County Sheriff Department 'Evidence/Property Custody' documents regarding the property obtained during the search of item #7922, #7923, and #7947. All items obtained during the search of item #7923 on 12/19/2005 was placed on a one page 'Evidence/Property Custody' document. All items obtained during the search of item #7922 and item #7947 were placed on a three page 'Evidence/Property Custody' document. Both aforementioned Calumet County Sheriff Department 'Evidence/Property Custody' documents will be included in the case file.
