On Tuesday, January 3, 2006, Delores Avery telephoned S/A Thomas J. Fassbender on his cellular telephone. Delores Avery asked S/A Fassbender about a "card" for the "snowmobile." S/A Fassbender believed Delores Avery to be talking about the snowmobile that was in Steven Avery's garage. S/A Fassbender believed Delores Avery to be talking about the title and/or registration to that snowmobile. Delores Avery advised they want to try and sell the snowmobile and need the card. S/A Fassbender agreed to contact Detective Mark Wiegert, of the Calumet County Sheriff's Department, and have him check to see if that was taken as a result of the search of the Avery property.

Later that day, S/A Fassbender attempted to contact Delores Avery and had telephone contact with Allan Avery. S/A Fassbender explained that he was trying to get a hold of Delores reference her request from earlier that day. While speaking with Allan Avery, he asked about his record book that he uses to record vehicle transactions in. S/A Fassbender advised he would check with the District Attorney to see if it could be returned. S/A Fassbender advised that he had provided Allan Avery with copies that he could use. Allan Avery agreed to have Delores Avery telephone S/A Fassbender.

A short time later, Delores Avery did telephone S/A Fassbender. S/A Fassbender spoke with Delores Avery about the items she had requested earlier, because S/A Fassbender could not remember what it was and at that time Delores could not remember. At a subsequent contact that day Delores advised it was the card for the snowmobile, which was the snowmobile title and/or registration.

On Monday, January 9, 2006, in the morning hours, Delores Avery telephoned S/A Fassbender on his cellular telephone. Delores Avery asked S/A Fassbender about the snowmobile "card," her golf cart, the records book for the business, and Steven Avery's car. S/A Fassbender advised that the golf cart was not processed but it was scheduled to be processed either this week or the following week, that he had contacted the Calumet County Sheriff's Department about the snowmobile title and had not been told anything about that, that S/A Fassbender had not talked with the District Attorney about the records book, and that he would contact the D.A. about Steven Avery's vehicle. The contact was then concluded.
