On November 7, 2005 from approximately 10:13 am until 10:22 am, S/A James A, Sielehr telephonically interviewed DALE OLSON, (white male, DOB: 03/18/1967), at cell phone number (920) 901-3835. DALE OLSON had previously contacted local law enforcement in Manitowoc County to provide tip information related to CHUCK AVERY.

DALE OLSON provided the following voluntary information:

DALE OLSON was employed at PIETROSKI'S TRUCK CENTER located at 1211 South 16th Street, Manitowoc, Wisconsin 54220. Pietroski's Truck Center is a General Motors dealer.

DALE OLSON recalled being present at the MENARDS Store in Manitowoc, Wisconsin on Thursday, November 3, 2005 at approximately 9:00 pm. The MENARDS described by DALE OLSON was MENARDS Store # 3141, which was located at 5120 Calumet Avenue, Manitowoc, Wisconsin 54220.

DALE OLSON observed CHUCK AVERY departing the exterior lumber yard at MENARDS at approximately 9:00 pm. CHUCK AVERY was picking up wood, insulation and other construction materials for a storage shed.

DALE OLSON specifically recalled that CHUCK AVERY stood out more so than usual and was "all neat and cleaned up". DALE OLSON has known CHUCK AVERY for a number of years, due to the fact that DALE OLSON had been trying to sell General Motors brand work trucks to the AVERY AUTO SALVAGE business. DALE OLSON specifically recalled that CHUCK AVERY was driving a red in color 2005 International brand wrecker truck.

DALE OLSON did not observe STEVEN AVERY, while at MENARDS on Thursday evening, November 3, 2005.
